

Part of the Southwest Quarter of the Southwest Quarter ($SW\frac{1}{4}$ of $SW\frac{1}{4}$), Section Eighteen (18), Township Seventeen (17) North Range Three (3) West, lying North and West of the Chicago, Milwaukee, St. Paul and Pacific Railroad right-of-way, described as follows:

Beginning at the Southwest corner of the $SW\frac{1}{4}$ of $SW\frac{1}{4}$, Section 18, thence due North along the Section line to the center of the Township Highway which runs parallel with the C.M. St. P. & P. R.R. right-of-way which center of the highway is the starting point, thence Northeasterly along the center of the Highway parallel with said railroad right-of-way a distance of 442 feet, thence Northwesterly at right angles a distance of about 450 feet to the section line, thence South a distance of 650 feet more or less to the place of beginning.

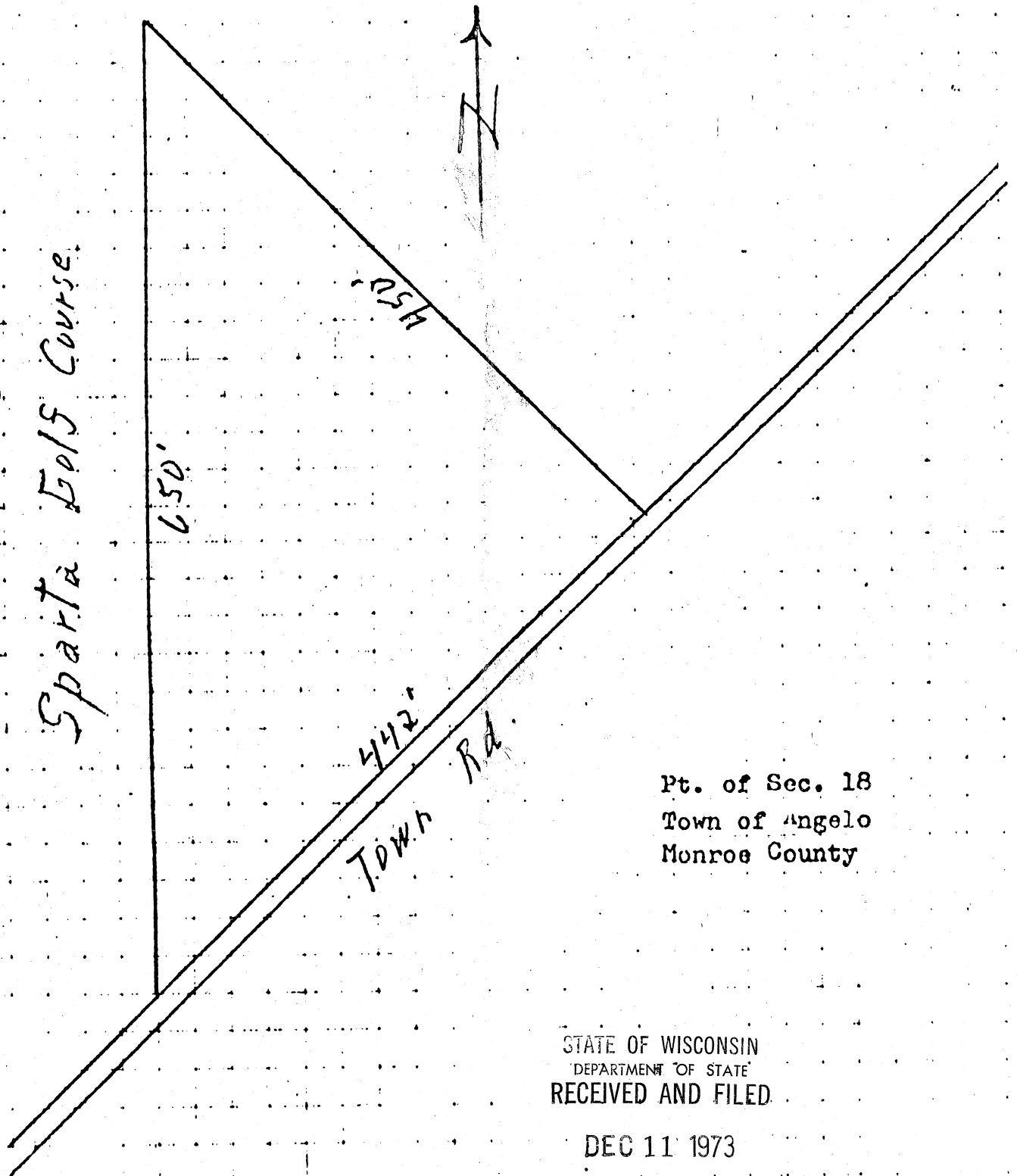

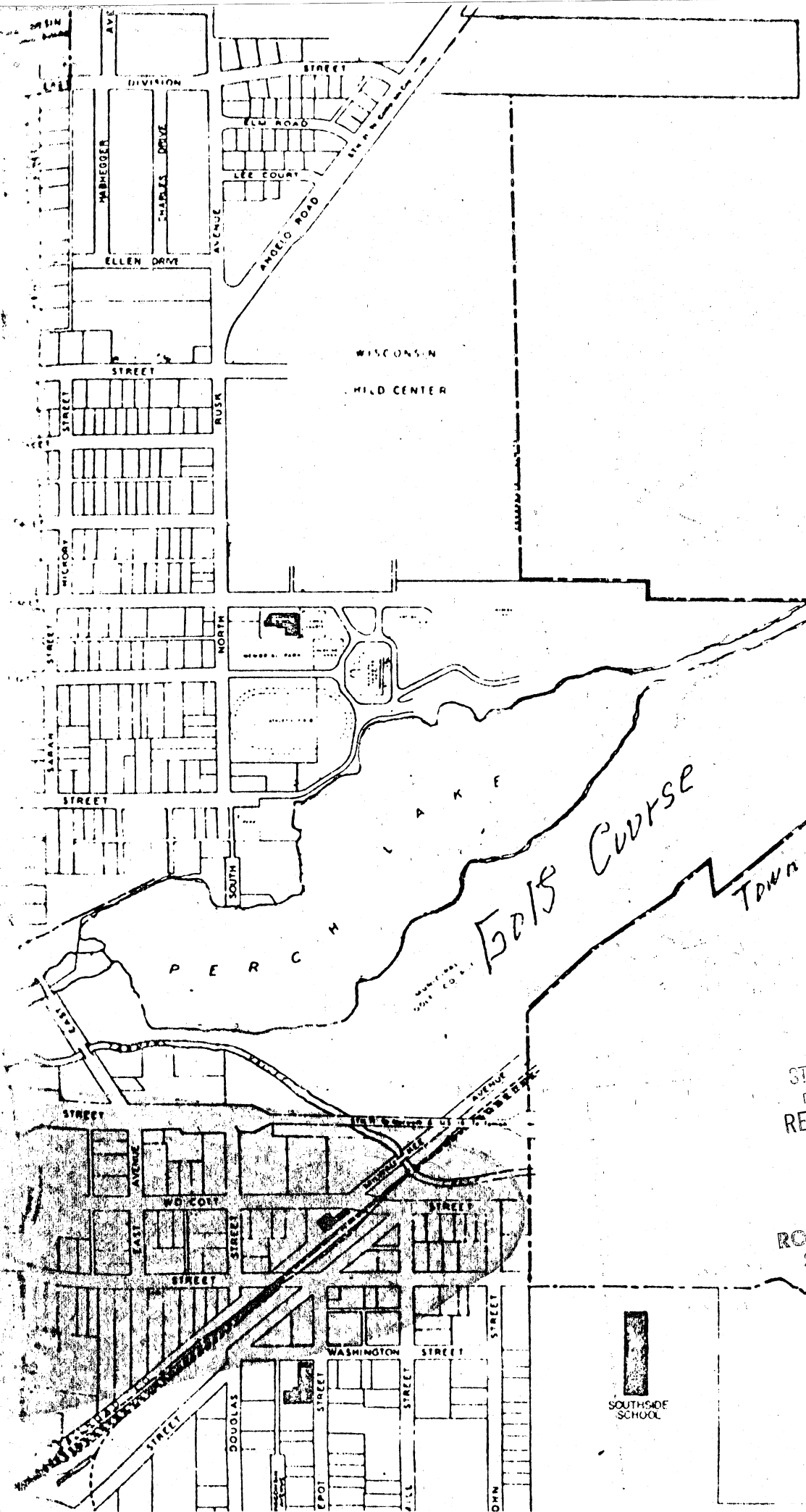


Pt. of Sec. 18
