A CHARTER ORDINANCE TO AMEND SECTION 2.01, COMMON COUNCIL, OF THE MUNICIPAL CODE OF THE CITY OF SHAWANO BY ADDING SECTION 2.01(3) ALDERMEN.

THE COMMON COUNCIL OF THE CITY OF SHAWANO DO ORDAIN AS FOLLOWS:

That Section 2.01, Common Council, of the Municipal Code of the City of Shawano be amended by adding Section 2.01(3), Aldermen, as follows:

"2.01(3) Alderman. There shall be one (1) Alderman from each Ward who shall be elected at the regular City election for the year 1968 for a term of one (1) year commencing on the third Tuesday of April. Commencing with the regular City election for the year 1969, there shall be one (1) Alderman from each Ward who shall be elected for a term of two (2) years commencing on the third Tuesday of April in the year of his election."

This Ordinance shall, subject to the provisions of Wis. Stat. 66.01(5), take effect sixty days after its passage and publication.



ORDINANCE NO. 459

A CHARTER ORDINANCE TO AMEND SECTION 1.12, ELECTIONS, OF THE MUNICIPAL CODE OF THE CITY OF SHAWANO BY ADDING SECTION 1.12(3), SPRING PRIMARY, WHEN NECESSARY.

THE COMMON COUNCIL OF THE CITY OF SHAWANO DO ORDAIN AS FOLLOWS:

That Section 1.12, Elections, of the Municipal Code of the City of Shawano be amended by adding Section 1.12(3), Spring Primary, When Necessary:

"1.12(3) Spring Primary; When Necessary. A spring primary shall be held for the nomination of candidates for a city office whenever 3 or more candidates file nomination papers for such office. If candidates for any city office are so nominated by primary, no further candidates shall be nominated by nomination papers.

This ordinance shall, subject to the provisions of Wis. Stat. 66.01(5), take effect sixty days after its passage and publication.
