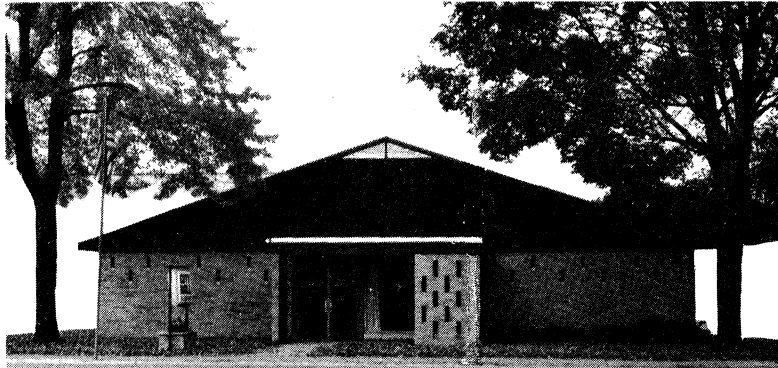

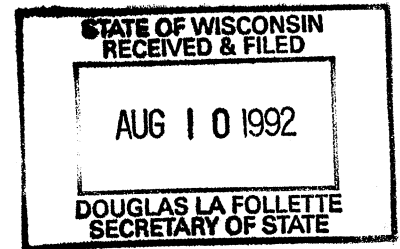

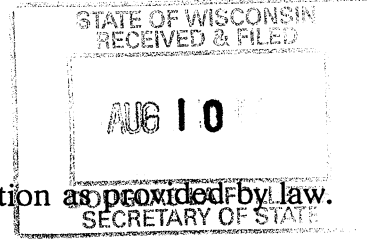

ORDINANCE NO.: 1108

THE COMMON COUNCIL CITY OF SHAWANO, WISCONSIN, DO ORDAIN that the Municipal Code of the City of Shawano is hereby amended to annex the following property as follows:

1. **AUTHORITY.** Pursuant to Section 66.021, Wis. Stats., the Common Council may annex territory pursuant to Petition signed by the owners of all of the real property sought to be annexed, which territory was contiguous to the City of Shawano.
2. **TERRITORY ANNEXED.** The City of Shawano Common Council hereby annexes the following described property: Lot 2, Certified Survey Map No. 862, recorded in the office of the Shawano County Register of Deeds on December 1, 1988 at 10:45 A.M. in Volume 3 of Certified Surveys, Pages 208-209 as Document No. 422979. The above described property is located in the Town of Waukechon, Shawano County, Wisconsin. The above described property is hereby annexed to the City of Shawano, Wisconsin.
3. **ZONING CLASSIFICATION.** The above described property that is hereby annexed to the City of Shawano shall be zoned in a manner not contrary to any town or county zoning regulation. The property shall be temporarily zoned FD Future Development District. At the time of the Common Council acting upon said Resolution, the Plan Commission of the City of Shawano has already made a recommendation to the Council to rezone said property from FD Future Development District to IP Industrial Park District.
4. **WARD DESIGNATION.** The property described in this Ordinance is hereby made a part of the 6th Ward, 3rd Aldermanic District of the City of Shawano.
5. The area which is hereby annexed is presently located in the Town of Waukechon, Shawano County, Wisconsin and said territory shall be detached from said Town and shall be attached to the City of Shawano, Shawano County, Wisconsin. Wis. Section 66.021(12).
