



SCHRADER, City Clerk of the City of Waukesha, County of Waukesha, State of Wisconsin, DO HEREBY CERTIFY that the following described territory was detached from the Town of Waukesha and was annexed to the said City of Waukesha, pursuant to Section 66.021 of the Wisconsin Statutes, by an ordinance adopted by the Common Council at a regular meeting held March 18, 1969.

All that part of the Southeast $\frac{1}{4}$ Section 16, Township 6 North, Range 19 East, in the Town of Waukesha, Waukesha County, Wisconsin, bounded and described as follows: Commencing at the East $\frac{1}{4}$ corner of Section 16; thence South $89^{\circ} 41'$ West along the East $\frac{1}{4}$ line of said Section 665.46 feet to the place of beginning of land to be described; thence South $00^{\circ} 13'$ East 670.00 feet to a point; thence South $89^{\circ} 41'$ West and parallel to the East $\frac{1}{4}$ line of said Section 664.96 feet to a point; thence North $00^{\circ} 13'$ West 670.00 feet to a point on the East $\frac{1}{4}$ line of said Section; thence North $89^{\circ} 41'$ East on and along the East $\frac{1}{4}$ line of said Section 664.96 feet to the place of beginning.



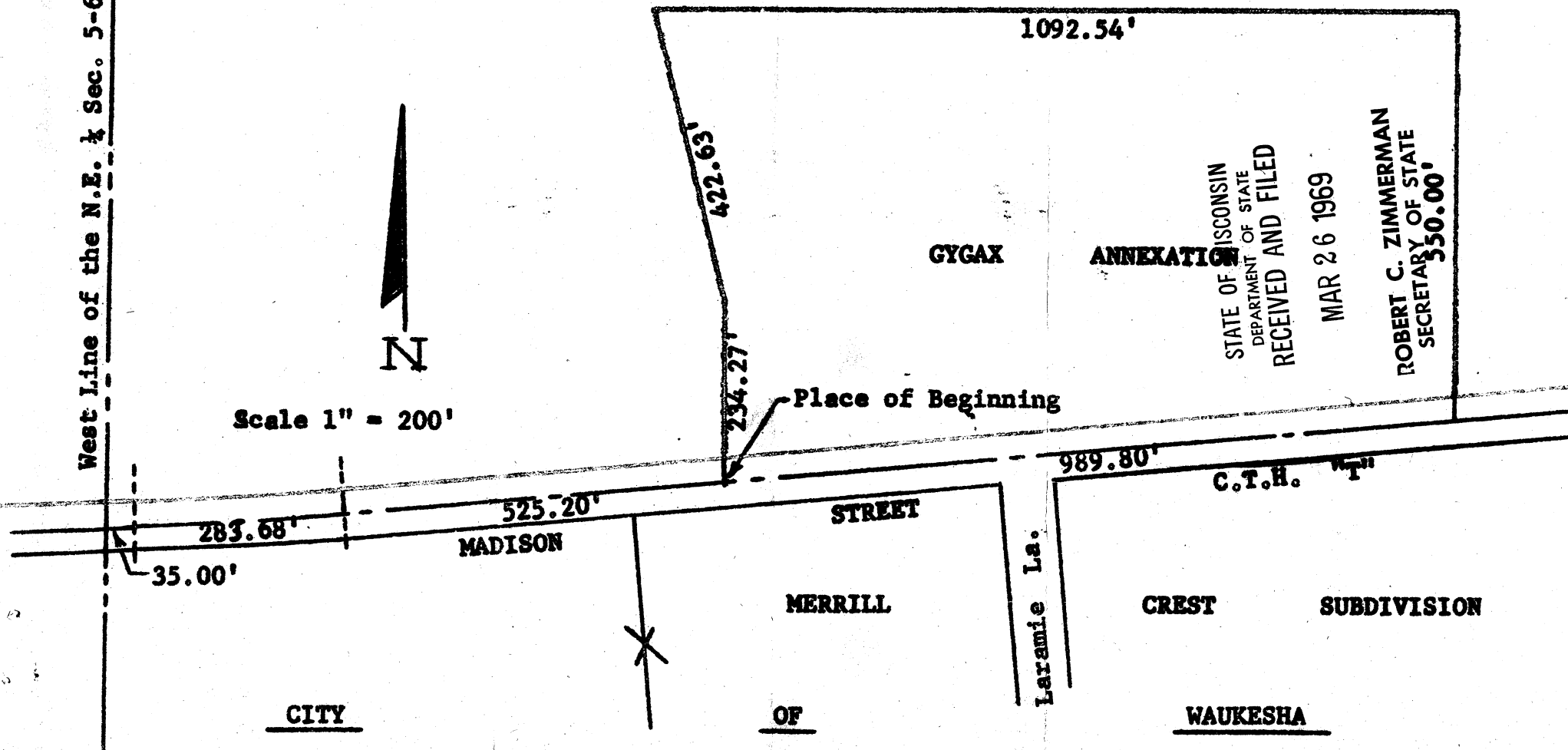
