



I, RUTH J. GOETZ, Deputy City Clerk of the City of Waukesha, County of Waukesha, State of Wisconsin, DO HEREBY CERTIFY that the following described territory was detached from the Town of Waukesha and was annexed to the said City of Waukesha pursuant to Section 66.021 of the Wisconsin Statutes, by an ordinance adopted by the Common Council at a regular meeting held December 16, 1969.

ALL THAT PART OF the Northeast Quarter (NE $\frac{1}{4}$ ) of Section 11, Town 6, North, Range 19 East, Town of Waukesha, Waukesha County Wisconsin bounded and described as follows:

Commencing at the Southeast corner of Lot 1, Block 15, the Meadows 3rd Add., a recorded subdivision; thence North 1°14'18" East along the East line of said subdivision 125.16 feet to the place of beginning of the land hereinafter to be described said point also being on the corporate limits of the City of Waukesha; thence continuing North 1°41'18" East along said East subdivision line and corporate limits 120.76 feet to the southwest corner of the property described as Parcel "1" in Volume 922 of Deeds on Page 4 as Document No. 569333; thence North 41°25'48" East along the southeasterly line of said property described in Document No. 569333, 243.53 feet to the southwest corner of the property described in Volume 589 of Deeds on Page 165 as Document No. 373400; thence South 48° 34' 12" East along the southerly line and southerly line extended of the property described in said Document No. 373400, 235.00 feet to the Easterly line of the Fay Gray property; thence South 41°25'48" West along the easterly line of said Fay Gray property 90 feet to an angle point in said property line; thence South 1°41'18" West along said easterly property line 100 feet more or less to a point on the corporate limits of said City of Waukesha; thence following the various bearings and distances of said corporate limits in a general westerly and northerly direction to the place of beginning.

This certification describing the annexed area is made in accordance with Section 66.021 of the Wisconsin Statutes.
