

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF NEW RICHMOND, WI

THE COMMON COUNCIL OF THE CITY OF NEW RICHMOND FOLLOWS:

Section 1. Territory Annexed. The following described territory presently located in the Town of Star Prairie, is hereby annexed to the City of New Richmond.

That part of the NE 1/4 of the NW 1/4 and that part of the NW 1/4 of the NE 1/4 all in Section 25, Township 31 North, Range 18 West, St. Croix County, Wisconsin, described as follows:

Commencing at the North 1/4 of said section 25, thence N 89 $^{\circ}$  23" W, 153.76 feet along the North line of said Northeast 1/4 of the Northwest 1/4 to the point of beginning; thence continuing N 89^ 38' 23" W, 505.74 feet to the Northeast corner of that parcel described in Lis. Pend. #273061, in the Register of Deeds Office, in and for St. Croix County, Wisconsin; thence S 0^ 06' 18" E, 447.90 feet along the Easterly line of said parcel described in Lis. Pend. #273061 to the Northwest corner of that parcel recorded in Vol, Page 510 to the East line of the West 1/4 of the North west 1/4 of the Northeast 1/4 of said section 25; thence N 0^ 13' 47" W, 2.99 feet to the Northwest corner of that parcel recorded in Vol. 396 of deeds page 626 in said Register of Deeds Office; thence S 46^ 31' 23" E, 122.20 feet along the Northeasterly line of said parcel described in Vol. 396 of deeds page 626 to the South line of the Northwest 1/4 of the Northeast 1/4; thence S 89^ 35' 12" E, 575.50 feet along said South line of the Northwest 1/4 of the Northeast 1/4; thence N 36^ 53' 57" W, 1644.98 feet to the point of beginning.


It is the intention that the above land description for the subject parcel describe the parcel as being adjacent to and abutting airport lands. Subject to all easements of record. Containing 20.97 acres more or less, including road right of way.

Section 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of New Richmond, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of New Richmond.

Section 3. Permanent Zoning Classification. (a) Upon recommendation of the City Council of the City of New Richmond the territory described above, annexed to the City of New Richmond by this ordinance is designated as aviation zoning only. (b) the boundaries of the annexed territory are established as shown on the map filed in the office of the City Clerk of the City of New Richmond.

Section 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby designated as a part of Ward 1, Aldermanic District 1 of the City of New Richmond.

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.



Section 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.




