LEGAL DESCRIPTION OF THE CITY BOUNDARIES OF THE CITY OF EVANSVILLE, WIS. AS THEY EXISTED ON DECEMBER 1,

Beginning at the southeast corner of the W½ of the W½ of Section 26, Town 4 North, Range 10 East (Town of Union, Rock Co., Wis.); thence North along the North line of said W½ of the W½ to the north line of said Sec. 26; thence west along the north section line of Sections 26, 27, and 28 in said Town to the northwest corner of the E½ of the E½ of said Section 28; Thence south along the west line of the E½ of the E½ of Section 28 to the south section line of said Section 28; thence continuing south along the center line of Milbrandt Road 350 ft.; thence south 89° 38' East, 666.15 ft. to an iron pipe monument; thence north 0° 29' East to the south line of said Section 28; thence east along the south Section line of Sections 28, 27, and 26 is said Town to the place of beginning;

Also, a parcel of land located in the NE% of the NW% of Section 34, T4N, RIOE, Town of Union, Rock County, Wisconsin, to-wit: Commencing at a point of intersection of the center line of Second Street and the northwesterly r/w line of Old Hwy. 92; said point being the point of beginning; thence N 1° - 05'W, (this bearing assumed) along the centerline of Second Street, 540.16 feet; thence S89° - 58'E, 198.00feet; thence N 1° - 04' W. 120.00 feet; thence N 90° -00'E, 341.00 feet; thence S 00° -00'E, along the west r/w line of First Street, 71.21 feet to the northwesterly r/w line of Old Hwy. 92; thence S 41° -47'W along said northwesterly r/w line 789.85 feet to the point of beginning and containing 3.97 acres.

Also, a parcel of land in the NW½ of the NE½ of Section 34, Town 4 North, Range 10 East, Town of Union, Rock County, Wis. to-wit: Commencing at the North ½ corner of said Section 34; thence East (assumed bearing) 231' along the North line of said Section 34 to a point; thence South 0° 06" West, 165' parallel to the West line of the E½ of Said Section 34; thence West parallel to the north line of Section, 231' to the West line of the NE½ of said Section34; thence North along said West line 165' to the point of beginning.

Also, beginning at a point on the south margin of Walker Street of the City of Evansville, Rock County, Wis., thirty-four and one-half (34½) rods East of the North West corner of the North East Quarter of Section 34, Town 4 North, Range ten (10) East and run thence East along the south margin of Walker Street seventy-four (74) feet more or less to the West margin of lands now owned by Aurell M. Vreeland and Pherme E. Vreeland as described in deed recorded in Office of Register of Deeds for Rock County, Wis. in Volume 283 of Deeds, Page 276; run thence south along the west margin of said Vreelands' premises ten (10) rods; run thence west seventy-four (74) feet more or less parallel with the south margin of Walker Street to a point thirty-four and one-half (34½) rods west of the north and south center line of said Section 34 and ten rods south of said starting point; thence north ten (10) rods to the place of beginning.

Also, beginning at a point on the South City Limits of Evansville which is 20 rods East of a point where the East line of Cherry Street in Evansville if extended would intersect the South City Limits; thence East along the South line 4 rods and 10'; thence South 10rods; thence West parallel with South line; thence Northe 10 rods to the place of beginning.

Also, beginning at a point on the South City Limits of Evanville which is 131 feet West of a point where the West line of Cherry Street in Evansville if extended would intersect the said South line; thense South 330'; thence West 320'; thence North 165'; thence East parallel with the South line of City Limits 155'; thence North 165' to the South City Limits of Evansville; thence East along the said South Line 165' to the place of beginning. All of the above property being in Section 34, Town 4 North, Range 10 East, Union Township, Rock County, Wis.

Also, part of Section 26, Town 4 North, Range 10 East, as follow: Beginning at the northwest corner of the NE¼ of the SW¼ of said Section 26 (said point also being a point on the east City Limits of the City of Evansville, Rock County, Wisconsin where said east city limits is intersected by the center line of U.S. Highway 14); thence east along the center line of said U.S. Highway 14 a distance of 276.5'; thence south from the center line of said U.S. Highway 14, 12 rods; thence west 276.5' to the east city limits of said City of Evansville; thence north 12 rods to the place of beginning.
