

ORDINANCE NO. 1985-4

AN ORDINANCE ANNEXING CERTAIN LANDS FROM THE TOWN OF RICHLAND INTO THE CITY OF RICHLAND CENTER, RICHLAND COUNTY, WISCONSIN.

The Common Council of the City of Richland Center, Wisconsin, does hereby ordain as follows:

SECTION 1. The following described property located in the Town of Richland contiguous to the City of Richland Center, Wisconsin, is hereby annexed into the City of Richland Center, Wisconsin:

A parcel of land located in part of the NW4-NE4 of Section 28, Town 10 North, Range 1 East, City of Richland Center, Richland County, Wisconsin, described as follows: Commencing at the North 1/4 corner of said Section 28; thence South 54° 52' 30" East, a distance of 471.59 feet, to a point on the right-of-way of U.S. Highway "14" and Bohmann Drive; thence Southeasterly along the rightof-way of U.S. Highway "14" and the arc of a curve, concave to the Northeast, having a radius of 1697.02 feet (the chord of which bears South 51° 26' 59" East, 467.00 feet) a distance of 468.49 feet, to the point of beginning; thence continuing along said right-of-way and the arc of a curve concave to the Northeast, having a radius of 1697.02 feet (the chord of which bears South 64° 17' 37" East, 292.07 feet) a distance of 292.43 feet, to the Westerly boundary of lands described in Volume 159, Page 525 of Deeds; thence South 0° 04' 04" East, along said Westerly boundary, a distance of 316.95 feet to the Northerly right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railroad: thence Northwesterly along the right-of-way of the Chicago, Milwaukee, St. Paul and Pacific Railroad and the arc of a curve concave to the North, having a radius of 1859.85 feet; (the chord of which bears North 74° 30' 42" West, 318.69 feet) a distance of 319.09 feet; thence North 6. 55' 48" East, a distance of 361.17 feet, to the point of beginning.

Containing approximately 2.2 acres.

SECTION 2. The above-described property is annexed as "R-1," Single-Family Residential.


