This is to certify that on September 21, 1954, the City Council took action to annex to the City of Fort Atkinson the following described properties:

Beginning at a point on the center line of the highway leading from Fort Atkinson to Janesville and on the north line of the N.W. 2 of Section 9, Township 5 North Range 14 East; thence southerly along the center line of said highway 594.1 feet; thence South 860 042: East, 268.26 feet; thence North 510 East, 85.61 feet; thence North 170 442: East, 275.77 feet; thence East parallel to the said Section 9 to the west line of Talcott's Hillside Addition in the Town of Koshkonong; thence North 287.2 feet to the north line of said Section 9, being the south City Limits of the City of Fort Atkinson, Wisconsin; thence West along the north line of said Section 9 to the place of beginning, containing 14.5 acres more or less.

Lots 66, 67, and 68 and that protion of Charles Street lying north of said lots, Snover's Prospect Heights Addition, being more particularly described as beginning at the S.E. corner of Lot 66 of said addition; thence N. 0° 25* W. 180 feet; thence West 192.75 feet; thence S. 0° 25* E. 180 feet; thence East 192.75 feet to the place of beginning, containing 0.8 acre more or less.

It is further certified that ninety days have passed since the passage of the annexation ordinance and that no action has been taken to question the proceedings.

All of that territory lying in the county of Jefferson and inscluded within the following described limits and boundaries shall constitute the City of Fort Atkinson, to-wit: Beginning at the section stone at the Southwest corner of Section 3, Township 5 North, Range 14 East of the fourth principal meridian; thence East on the South line of said Section 3 one thousand one hundred and eighty (1180) feet to the center line of Whitewater Avenue; thence Southerly along the said center line six hundred and eighty-eight (688) feet; thence North eighty-nine degrees and thirty-eight minutes East (N. 890 38 E.) four hundred and three-tenths (400.3) feet to the center line of East Street extended; thence North zero degrees and forty-two minutes West




