

ORDINANCE NUMBER 285

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF ELROY, WISCONSIN.

WHEREAS, a petition for annexation of certain continguous territory has been filed with the Clerk of this City and with the Clerk of the Town of Plymouth in which the territory proposed to be annexed is located; and

WHEREAS, no electors reside in the territory proposed to be annexed and the owners of all the real property in such territory have signed said petition; and

WHEREAS, all the requirements of Wisconsin Statutes 66.021(12) appear to have been complied with;

THEREFORE, the Common Council of the City of Elroy do ordain as follows:


- 1. It is in the best interests of the public and of the City that the lands described in the petition for annexation be included in the limits of the City.

Said parcel contains 3.59 acres more or less and is subject to all easements and rightof-way of record.

3. The lands described herein shall be annexed to Ward


