ORDINANCE NO. 689

AN ORDINANCE ANNEXING TERRITORY CONTIGUOUS TO THE CITY OF ELKHORN, WALWORTH COUNTY, WISCONSIN.

The Common Council of the City of Elkhorn, Wisconsin, do ordain as follows:

SECTION ONE: (Territory Annexed) In accordance with S. 66.021(12) of the Wisconsin Statutes, the following described land located in the Town of Geneva, Walworth County, Wisconsin, and having been the subject of a Petition for Direct Annexation filed with the City Clerk of the City of Elkhorn on the 6th day of May, 1985, and more than twenty (20) days having passed since publication of the notice of intent to circulate the Petition and 120 days after the date of filing with the City having not yet passed, and a favorable report having been made by the Department of Development, the following described property is hereby annexed into the corporate limits of the City of Elkhorn:

The following described real estate located in the Town of Geneva, Walworth County, Wisconsin;

Lots One (1) through Twenty (20) of Oakwood Subdivision, Town of Geneva, Walworth County, Wisconsin; and

Lots one (1) through Fifty-eight (58) of Green Acres Subdivision, Town of Geneva, Walworth County, Wisconsin;

All of the above located in the Northwest one-Quarter (½) of Section Eight (8), Township Two (2) North, Range Seventeen (17) East, Town of Geneva, County of Walworth, Wisconsin, including the following named streets within the subdivision and that portion of County Trunk H that fronts on the annexed territory. The names of said streets are Robincrest, Larkdale, Meadowlark, Oakwood, Hickory Lane and Maclean Road and Glenridge Lane.

All as shown by scale map attached hereto as Attachment "A" and made a part of this Ordinance (circled in "red").

STATE OF WISCONSIN SECTION TWO: (Annexation into Ward) The said lands above described RECEIVED AND FILED hereby annexed to and made a part of the Second Ward of District One.

SECTION THREE: (Effect of Annexation) From and after the date of this Ordinance the territory described in Section One shall be a part of the City of Elkhorn for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Elkhorn, together with the Annexation Agreement, dated July 9, 1985, and signed by the City of Elkhorn by the Mayor and Clerk and the respective petitioners, Carol Kopp, Harold Minette, Ronald Edwards, Gregory Staponkus, Clayton Clement and Ronald Johnson.

SECTION FOUR: (Zoning Classification) The City Plan Commission is directed to prepare a recommendation for permanent classifications and regulations for the zoning of the annexed area and submit its recommendations to the Common Council as soon as possible.

SECTION FIVE: (Severability) If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION SIX: (Effective Date) The annexation hereinafter effected shall be effective upon the enactment of this Annexation Ordinance.

SECTION SEVEN: (Filing Copies) The City Clerk shall immediately file five (5) certified copies of this Ordinance including the scale map

attached hereto in the Office of the Secretary of State and one copy to RECEIVED AND FILED company that provides any utility service in the area so annexed, if

any, plus one such copy to the Register of Deeds for recording.
