

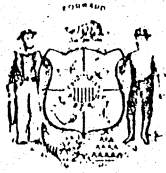

I, Betty Wassel, City Clerk of the City of Delavan, Walworth County, Wisconsin, do hereby certify that the attached and foregoing is a true and correct copy of Ordinance No. C-42, which was adopted by the City of Delavan Common Council on the 14th day of May, 1968. This ordinance annexed lands from the Town of Delavan to the City of Delavan (a description of which is attached hereto) and through an oversight, we believe, certified copies of said Ordinance were not filed with the Secretary of State.

Section 66.021(8)(a) states in part: "Failure to file shall not invalidate the annexation and the duty to file shall be a continuing one." We believe, through this correspondence, we have now fulfilled our obligation.

ORDINANCE NO. C-42

An ordinance annexing certain lands in the Town of Delavan to the City of Delavan.

The Common Council of the City of Delavan does ordain as follows:

1. The following described parcel of land is hereby annexed into the corporate limits of the City of Delavan:

A parcel of land located in the E $\frac{1}{2}$ of Sec. 19, T. 2 N.R. 16 E., City of Delavan, and Town of Delavan, Walworth County, Wisconsin, described as follows, to-wit: Commencing at the intersection of the N. line of Phoenix St. and the centerline of South Second St. in said City of Delavan; thence S. along the centerline of said South Second Street 2591.00 feet; thence S. 89° 58' E. 50.00 feet to the E'ly line of South Second St. and County Trunk Highway "O" and the place of beginning; thence continue S. 89° 58' E. 566.42 feet to the N.-S. $\frac{1}{4}$ th Sec. line of the SE $\frac{1}{4}$ of Said Sec. 19 as fenced; thence S. 0° 04' W. along said $\frac{1}{4}$ th sec. line 176.91 feet; thence N. 89° 58' W 566.22 feet to the E'ly line of said County Trunk Highway "O"; thence N. along said E. line 176.91 feet to the place of beginning, containing 2.30 acres of land more or less.

2. The afore-described parcel of land is hereby annexed to and made a part of the First Ward of the City of Delavan.

3. The lands described in paragraph 1 hereof shall have temporary zoning classification of R-1 (one-family dwelling district) until amendment of the zoning ordinance of the City of Delavan in the manner pre-

scribed by 62.23 (7) (d), Wisconsin Statutes.

4. The annexation hereinbefore effected shall be effective upon enactment hereof.
