AN ORDINANCE  
THE COMMON COUNCIL  
OF THE CITY OF BEAVER  
DAM DO ORDAIN AS FOL-  
LWS:

Section I: That the following described premises, contiguous to the City of Beaver Dam, be annexed to said municipality and to the Second Ward of said City, and pursuant to the said annexation, detached from the Township of Beaver Dam, Dodge County, Wisconsin, all of the same being hereby enacted pursuant to the due petition for annexation of the following described premises to the City of Beaver Dam, as filed with the City Clerk of Beaver Dam, Wisconsin, on the 8th day of September, 1970, and pursuant to Section 66.021(12) Wisconsin Statutes.

The NE 1/4 of the NW 1/4 of Section 9, T.11 N., R. 14 E. and a part of the NW 1/4 of the NW 1/4 of Section 9, described as follows: Commencing in the North line of said 1/4 1/4 section where it is intersected by the centerline of S. Spring St., thence SW'ly along said centerline of So. Spring St., four rods, thence E. to the E. line of said 1/4 1/4 section, thence N. on said E. line to the N. line of said section, thence W. on said N. line to the place of beginning. All in Township 11 N., Range 14 E.

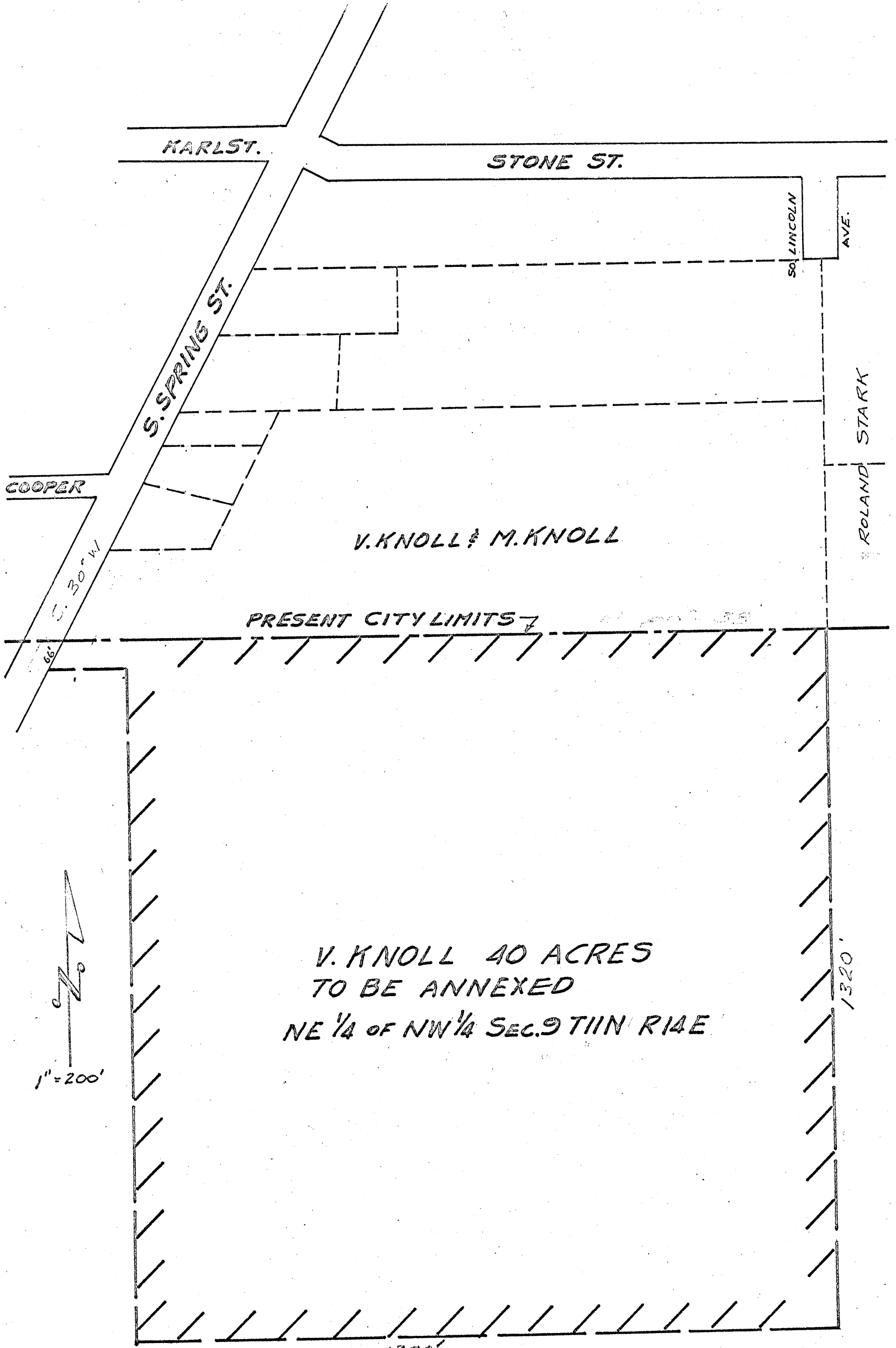
