AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF STEVENS POINT, WISCONSIN

The Common Council of the City of Stevens Point, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with Section 66.021 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 10th day of April, 1963, signed by the owners of one-half of the land in area in the territory, and whereas no electors reside in said territory, the following described territory in the Town of Hull, Portage County, Wisconsin, is annexed to the City of Stevens Point, Wisconsin:

The Southwest \$\frac{1}{4}\$ of the Northwest \$\frac{1}{4}\$ and the Northwest \$\frac{1}{4}\$ of the Southwest \$\frac{1}{4}\$ of Section Twenty-Eight (28) Township Twenty-Four (24) North, Range Eight (8) East in the Town of Hull, Portage County, Wisconsin.

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Stevens Point for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Stevens Point.

- SECTION 3. Temporary Zoning Classification. (a) Upon recommendation of the plan commission, the territory annexed to the City of Stevens Point by this ordinance is temporarily designated to be part of the Single Family Residence District of the City of Stevens Point for zoning purposes and subject to all provisions of the "Zoning Ordinance" of the City of Stevens Point relating to such district classifications and to zoning in the City.
- (b) The plan commission is directed to prepare an amendment to the zoning ordinance setting forth permanent classifications and regulations for the zoning of the annexed area and to submit its recommendations to the council not later than February 1, 1964.

SECTION 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the Eighth Ward of the City of Stevens Point, subject to the ordinances, rules and regulations of the city governing wards.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
