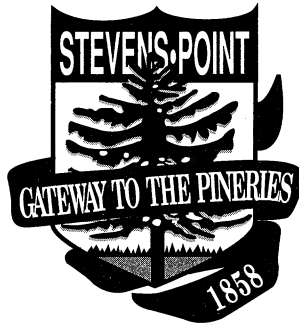

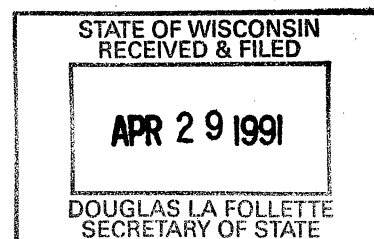
Enclosed a copy of an Ordinance Annexing Territory to the City of Stevens Point, along with a map and certification.



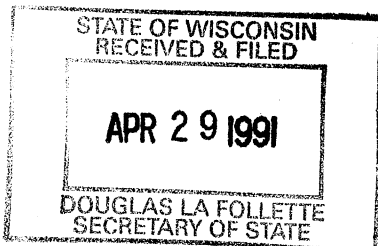

**AN ORDINANCE ANNEXING TERRITORY
TO THE CITY OF STEVENS POINT, WISCONSIN**

The Common Council of the City of Stevens Point, Wisconsin, do ordain as follows:

SECTION I: Territory Annexed. In accordance with Section 66.021 of the Wisconsin Statutes, the following described territory in the Town of Hull, Portage County, Wisconsin, is annexed to the City of Stevens Point, Wisconsin:

That part of the Southwest Quarter of Section 25; that part of the Southeast Quarter of Section 26; that part of the Northeast Quarter of Section 35 and that part of the Northwest Quarter of the Northwest Quarter of Section 36, Township 24 North, Range 8 East, Town of Hull, Portage County, Wisconsin described as follows:

Commencing at the northwest corner of Wildwood Drive and Windy Lane in said Section 35; thence north along the west right of way line of said Wildwood Drive to the north right of way line of Windy Lane and its westerly extension and the point of beginning; thence east along said north right of way line and its easterly extension to the east right of way line of Brilowski Road; thence north along said east right of way line to the north right of way line of Walter Street and its easterly extension; thence west along the north right of way line of Walter Street to the west right of way line of Wildwood Drive and its northerly extension; thence south along said west right of way line to the point of beginning and there terminating.

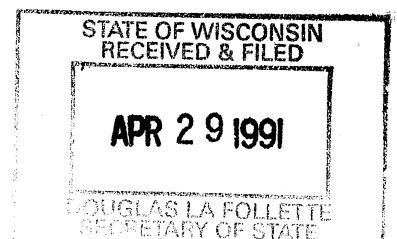
This annexation contains approximately 11.34 acres (does not include right of ways). [REFERENCE: TREDER ANNEXATION - BOUNDARIES: WILDWOOD/WALTER/BRILOWSKI/WINDY]

SECTION II: Effect of Annexation. From and after the date of this ordinance, the territory described in Section I shall be a part of the City of Stevens Point for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Stevens Point.

SECTION III: Zoning Classification. Such land shall be temporarily designated as R-LD Low Density Residential until the zoning ordinance is amended.

SECTION IV: Ward Designation. The territory described above is hereby made a part of the 12th Ward of the City of Stevens Point subject to the ordinances, rules and regulations of the City governing wards.

SECTION V: Severability. If any provision of this ordinance is invalid or unconstitutional or if the application of this ordinance to any person or



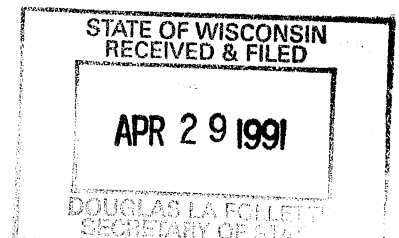
circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect any provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION VI: Effective Date: This ordinance shall take effect upon passage and publication as provided by law.

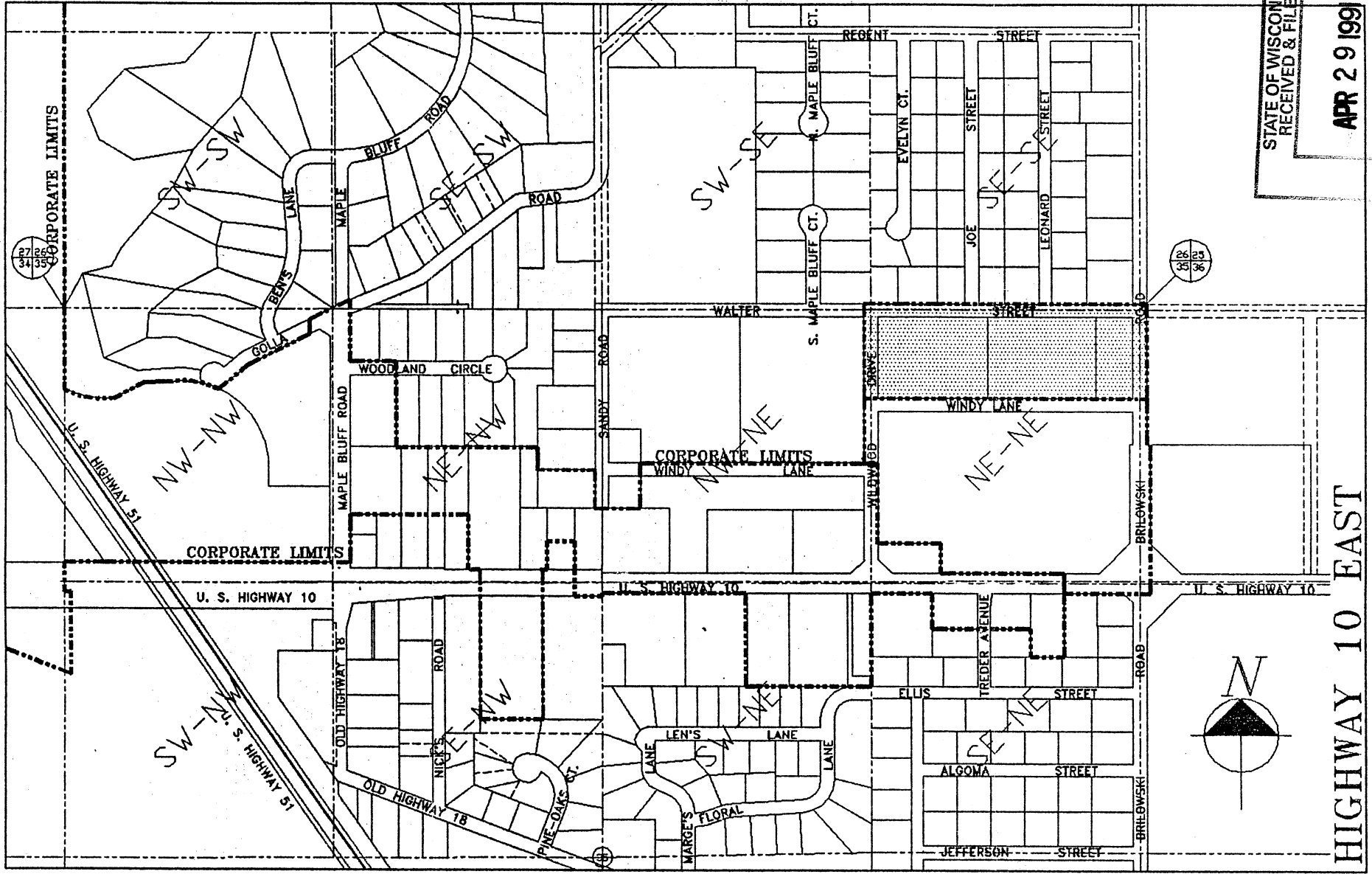

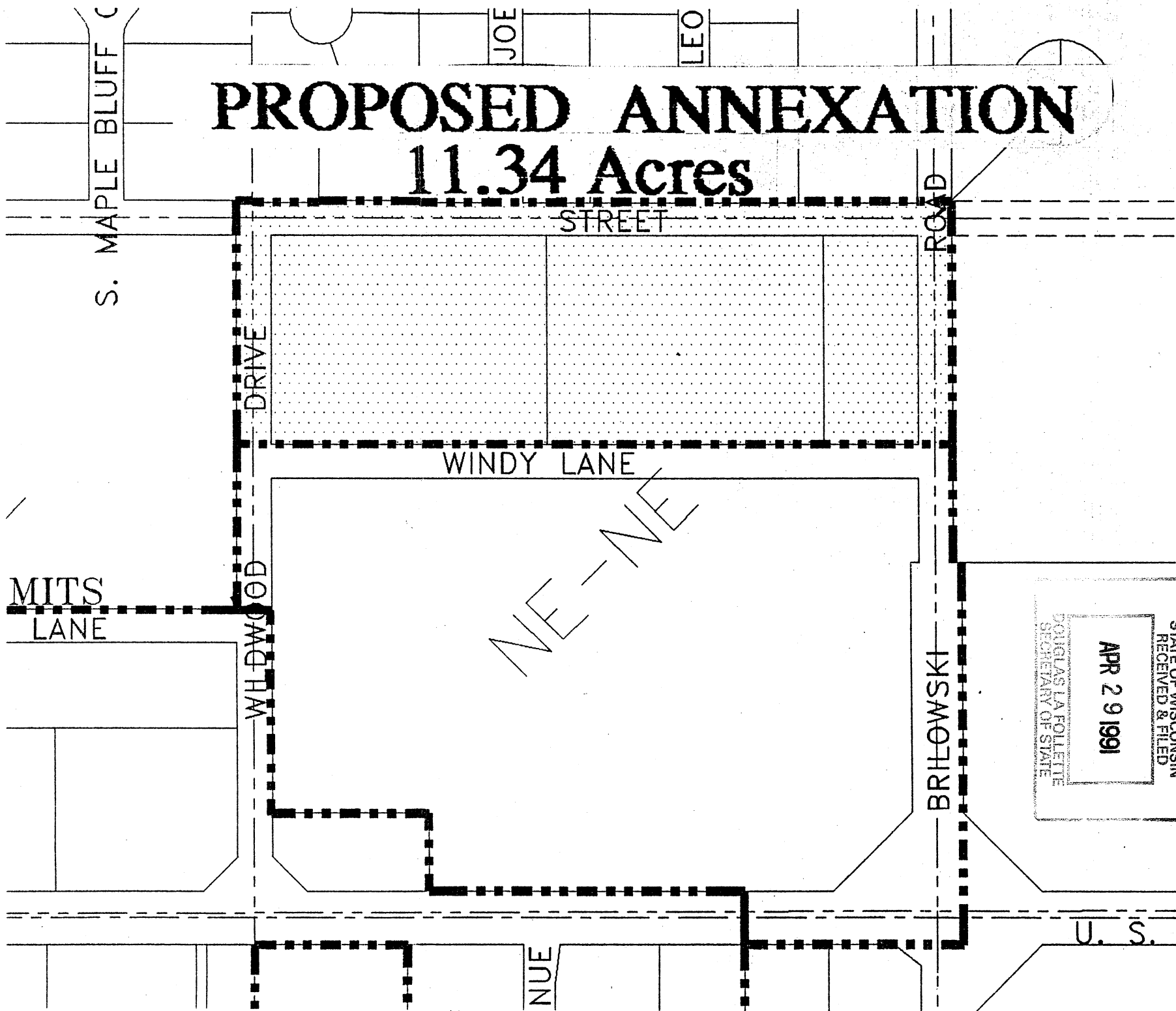
