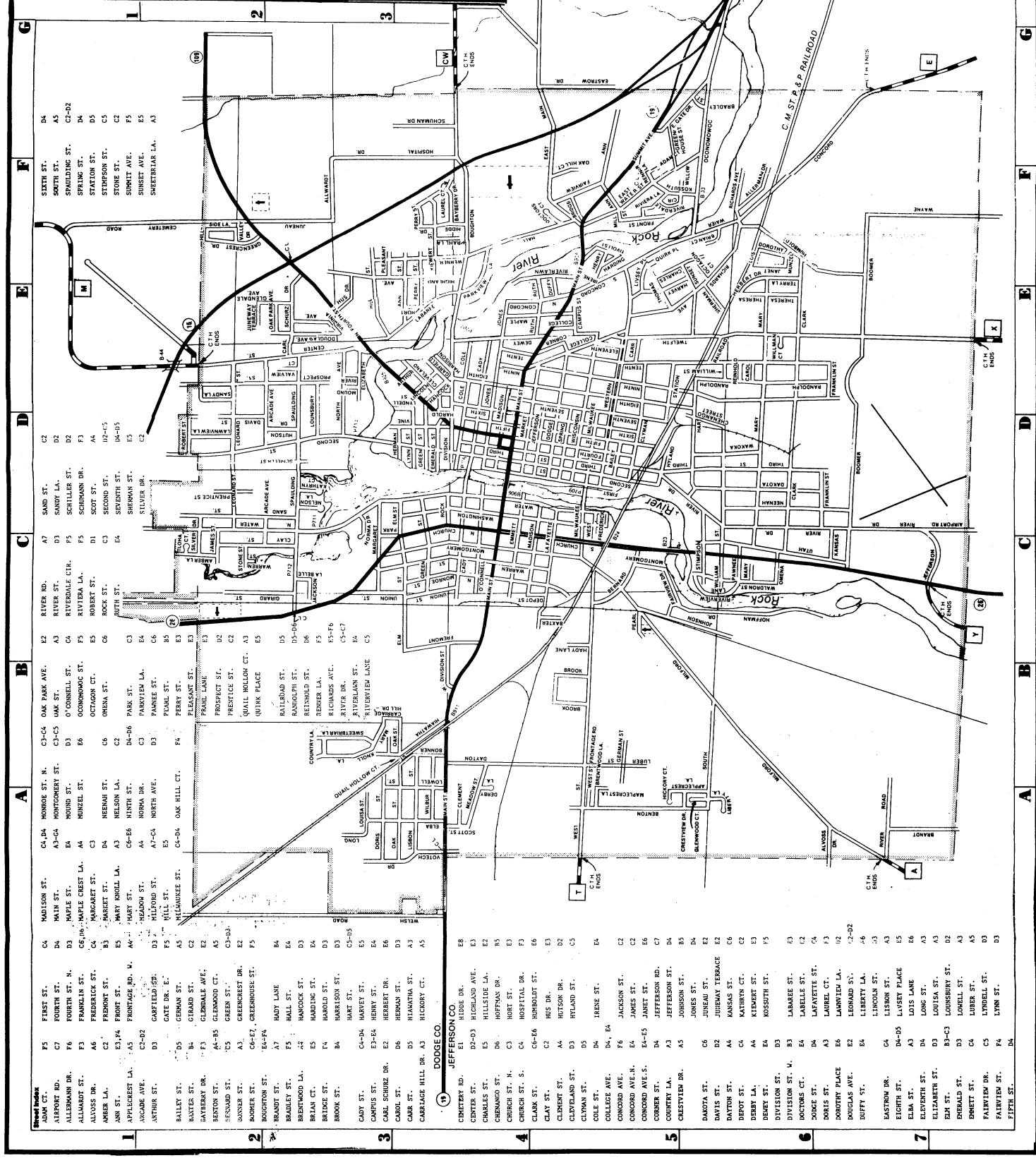
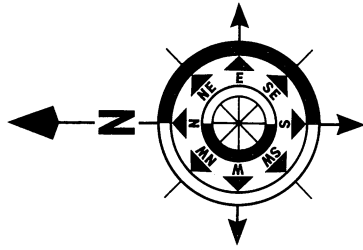
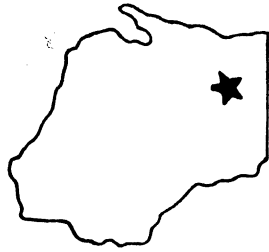

WHEREAS, Select Communications, Inc., a Wisconsin Corporation, has filed with the Common Council a Petition for the annexation of real estate to the City of Watertown, Jefferson County, Wisconsin, and

WHEREAS, a copy of said Petition has been given to the Watertown Planning Commission and the State Department of Development and also to the Town Board of the Town of Watertown in compliance with Section 66.021 (11) of the Wisconsin Statutes, and

WHEREAS, the Watertown Planning Commission and the Wisconsin Department of Development have indicated their support for the annexation:

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF WATERTOWN DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1: That the following described real estate be and the same is hereby annexed to the corporate city limits of the City of Watertown, from the Town of Watertown, Jefferson County, Wisconsin, to-wit:

A part of the N.E. 1/4 N.E. 1/4 of Section 6"8"15, Town of Watertown, bounded and described as follows: Commencing at the N.E. corner of Section 6; thence S. 89° 11' West along the North line of said Section, 628.57 feet; thence South, 547 feet to the point of beginning; thence continuing South 407.77 feet to the North line of the Chicago, Milwaukee, St. Paul & Pacific Railway right of way; thence West along said right of way line, 404.96 feet; thence North, 402 feet; thence North 89° 11' East, 405 feet to the point of beginning. Containing 3.76 acres.

IT IS FURTHER ORDAINED AS FOLLOWS: That the above described real estate be zoned as a M-2 zoning district.

IT IS FURTHER ORDAINED AS FOLLOWS: That the above described real estate shall be made a part of the Twelfth aldermanic district of the City of Watertown, Jefferson County, Wisconsin.

SECTION 2. All ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed.

SECTION 3. This ordinance shall take effect and be in force the day after its passage and publication.
