ANNEXATION ORDINANCE

SPONSOR: Mayor Thiel  
FROM: Plan Commission

WHEREAS, Robert A. Bender, City Attorney for the City of Watertown, has filed with the Common Council a petition for the Annexation of real estate to the City of Watertown, Jefferson County, Wisconsin, and

WHEREAS, a copy of said Petition has been given to the Watertown Planning Commission and the State Department of Development and also to the Town Board of the Town of Watertown in compliance with Section 66.021 (11) of the Wisconsin Statutes, and

WHEREAS, the Watertown Planning Commission and the Wisconsin Department of Development have indicated their support for the annexation:

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF WATERTOWN DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1. That the following described real estate be and the same is hereby annexed to the corporate city limits of the City of Watertown, from the town of Watertown, Jefferson County, Wisconsin, to-wit:

A Part of the NW 1/4 of Section 16, T8N, R15E, located in Watertown Township, Jefferson County, Wisconsin, described as follows:

Beginning at the NW corner of said Section 16; thence East along the North line of Section 16 to the NE corner of the NW 1/4 of Section 16; thence South to the SE corner of the NE 1/4 of the NW 1/4 of Section 16; thence West to the centerline of Airport Road; thence North along the centerline of Airport Road to a point 1,067 feet South of the North line of Section 16; thence West 250.50 feet; thence South 100.00 feet; thence West to the West line of Section 16; thence North along the West line of Section 16 to the place of beginning.

IT IS FURTHER ORDAINED AS FOLLOWS: That the above described real estate be zoned as an agricultural zoning district.

IT IS FURTHER ORDAINED AS FOLLOWS: That the above described real estate located West of the Airport Road shall be made a part of the eighth aldermanic district of the City of Watertown, Jefferson County, Wisconsin, and that part of the above described real estate located East of the Airport Road shall be made a part of the Seventh Aldermanic District of the City of Watertown, Jefferson County, Wisconsin.

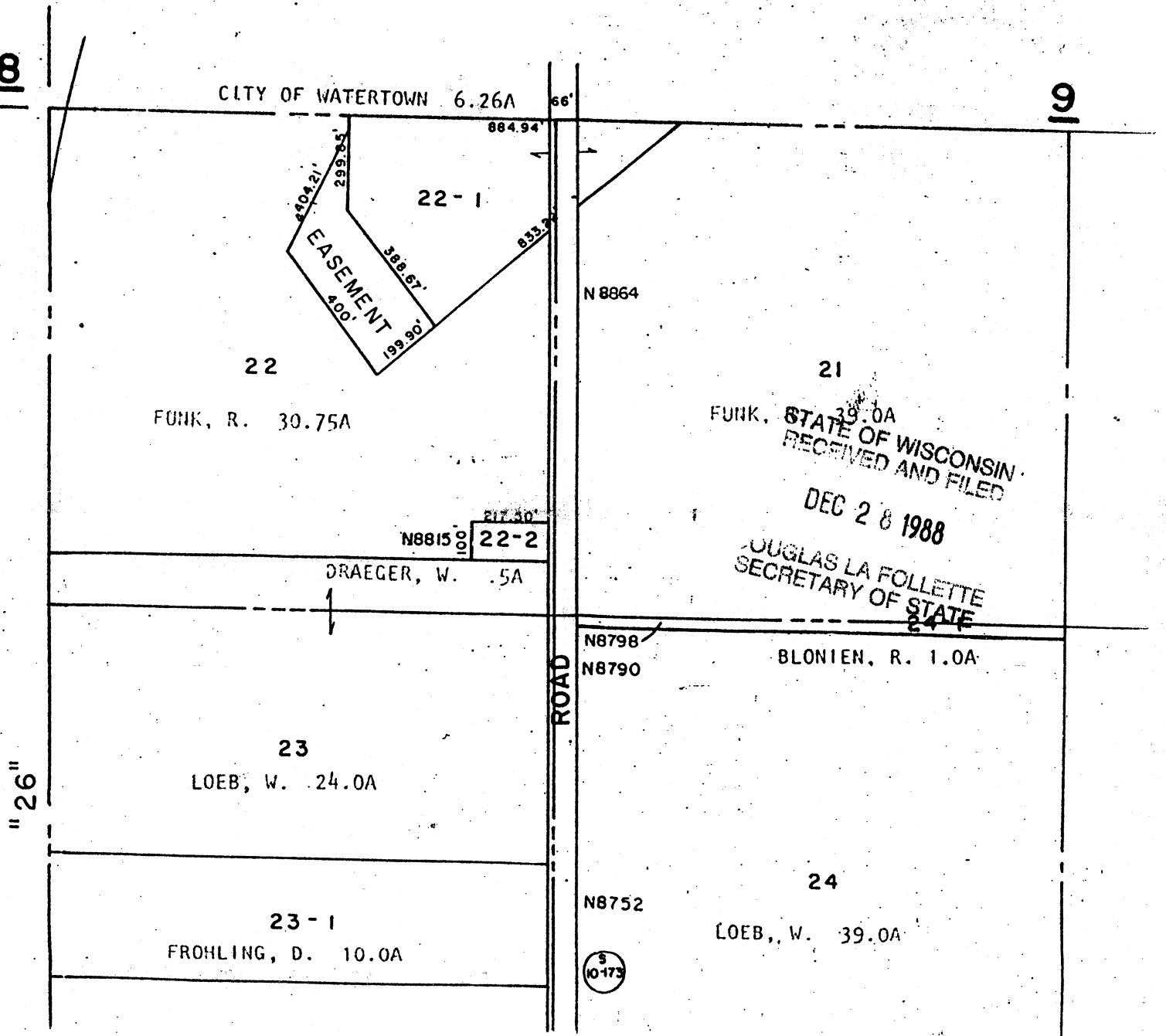
