

ORDINANCE NO. 57 (1982 Code)

An ordinance creating Ordinance No. 23 of Appendix "A" to the Municipal Code of the City of Marshfield, annexing certain lands to the City of Marshfield from the town of Marshfield, Wood County, Wisconsin.

The Common Council of the City of Marshfield, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with Section 66.021(12) of the Wisconsin Statutes of 1979-1980, and the petition for direct annexation filed with the City Clerk on the 24th day of June, 1982, signed by all of the owners of the territory proposed to be annexed, and all of the electors residing in such territory, and it appearing that the petitioners have complied with all of the requirements set forth in Section 66.021 (12) of the Wisconsin Statutes, the following described territory in the Town of Marshfield, Wood County, Wisconsin, is hereby annexed to the City of Marshfield, Wisconsin, and detached from the Town of Marshfield, Wood County, Wisconsin.

That part of the Northwest Quarter of the Northwest Quarter (NW-1/4 - NW-1/4) of Section Ten (10), Township Twenty-five (25) North, Range Three (3) East, described as follows:

Commencing at a point Two-and-one-half (2-1/2) rods South of the Northwest corner of the Northwest Quarter of the Northwest Quarter (NW-1/4 - NW-1/4) of said Section Ten (10), said Township and Range; running thence East, parallel with the North line of said Section, a distance of Eight (8) rods; thence South, parallel with the West line of said Quarter Section, Two Hundred Ninety-One Feet, 9 inches; thence West, parallel with the North line of said Section, Eight (8) rods; thence North, parallel with the West line of said Quarter Section, Two Hundred Ninety-One Feet, 9 inches, and to the place of beginning.

SECTION 2. Ward. Said territory is hereby made a part of the 18th Ward of the City of Marshfield.

SECTION 3. Zoning Classification. Said territory shall, upon annexation, be designated an "R-3" (Residential) District under the Zoning Ordinances of the City of Marshfield, subject to change as provided by Chapter 17 of the Municipal Code of the City of Marshfield, and such designation shall be inserted as s. 17.02(2) (o) of said Code.

SECTION 4. Effect of Annexation. From and after the date of the adoption and publication of this Ordinance, the territory described in Section 1 shall be a part of the City of Marshfield for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Marshfield.

SECTION 5. Severability. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstance is invalid or unconstitutional such unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or application.

SECTION 6. This Ordinance shall be known, as and shall hereafter be referred to, as Ordinance No. 23 of Appendix "A", of the Municipal Code of the City of Marshfield.

SECTION 7. Effective Date. This Ordinance shall take effect and be in force from and after its passage and publication as provided by law.

SECTION 8. The City Clerk shall file immediately with the Secretary of State a certified copy of the Ordinance, certificate and plat and one copy with each company that provides any utility service in the annexed area, plus one such copy with the Register of Deeds and one copy with the Clerk of any affected school district. The Clerk's certificate shall include a reference to the population of the territory as set forth in the petition, if any.

Note: This Ordinance is recommended by Alderman Stargardt.
