ORDINANCE NO.510A ORDINANCE ANNEXING TERRITORY TO THE CITY OF CHETEK, WISCONSIN

It is hereby ordained by the Common Council of the City of Chetek, Wisconsin, that the Code of Ordinances hereby read as follows:

SECTION 1. Territory Annexed.

In accordance with § 66.021, Wisconsin State Statutes, and the Petition for Direct Annexation filed with the City Clerk-Treasurer on the 10th day of January, 1995, signed by a property owner of at least 50% of the real property of the total area to be annexed, the following-described territories in the Town of Prairie Lake, Barron County, Wisconsin, are annexed to the City of Chetek, Wisconsin.

(a) Legal Description of Larry Stafsholt and Judith Stafsholt property:

PCL # 700 A 706 S24/T33/R11 ACRES 2.00 PLAT 3-5 & 4-6 THAT PRT OF THE S½ NE INCLUDE IN LOT A CSM 23/57

(SEE 036-4066-86 of the Prairie Lake real estate tax book)

and

PCL # 804 S24/T33/R11 LOT 72 CARTWRIGHT'S POINT (PRT LOT A CSM 23/57)



(SEE 036-2400-20 of the Prairie Lake real estate tax book)

SECTION 2. Effect of Annexation.

(a) The territory described in Section 1 shall be a part of the City of Chetek for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Chetek.

SECTION 3. <u>Temporary Zoning Classification</u>.

- (a) Upon recommendation of the Plan Commission, the territory annexed to the City of Chetek by this ordinance is temporarily designated to be part of the following district(s) of the City for zoning purposes and subject to all provisions of the C-3 Resort Commercial Zoning Ordinance of the City of Chetek relating to such district(s)' classifications and to zoning in the City.
- (b) The boundaries of the designated district are established as shown on the map filed in the office of the City Clerk-Treasurer, entitled, Barron County Survey Map, Chetek, Wisconsin, dated May 24, 1994.

(c) The Plan Commission is directed to prepare an amendment to the zoning ordinance setting forth the permanent classifications and regulations for the zoning of the annexed area and to submit its recommendation to the Common Council not later than April 1, 1995.

SECTION 4. Ward Designation.

The territory described in Section 1 of this ordinance is hereby made a part of the Fourth Ward of the City of Chetek, Wisconsin, subject to the ordinances, rules, and regulations of the City of Chetek governing wards.

SECTION 5. Aldermanic District Designation.

The territory described in Section 1 of this ordinance is hereby made a part of the Fourth Aldermanic District of the City of Chetek, Wisconsin, subject to the ordinances, rules, and regulations of the City of Chetek governing Aldermanic Districts.

SECTION 6. School District Affiliation.

The territory described in Section 1 of this ordinance is annexed for school purposes and is hereby made part of the Chetek School District and subject to all laws governing the same.

SECTION 7. Severability.

If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 8. Effective Date.

This ordinance shall take effect immediately upon passage and publication as provided by law.
