
AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF MEDFORD

THE COMMON COUNCIL OF THE CITY OF MEDFORD, TAYLOR COUNTY, WISCONSIN, DO HEREBY ORDAIN AS FOLLOWS:

SECTION 1: <u>Territory Annexed.</u> In accordance with Wisconsin State Statute 66.021 and the petition for direct annexation filed with the City Clerk on 16 July 1997, signed by all the electors and all of the owners of real property in the territory to be annexed, the following described territory in the Town of Medford, Taylor County, Wisconsin, is annexed to the City of Medford, Wisconsin:

A Parcel of land described as "Lot 1 of Certified Survey Map # 1014, Recorded 6 June 1997, in Volume 4-S of Surveys, Pages 281 and 282 in the Office of the Register of Deeds for Taylor County, Wisconsin, including that portion of the rights-of-way for County Trunk Highway 'O' and State Highway 13 contiguous to this property, and extending to the north right-of-way line of County Trunk Highway 'O' and the centerline of State Highway 13, and being a part of the Northwest Quarter of the Northwest Quarter of Section 1, Township 30 North, Range 1 East, Town of Little Black, Taylor County, Wisconsin."

- SECTION 2: <u>Effect of Annexation.</u> From and after the date of this ordinance, the territory described in Section 1 shall be part of the City of Medford for any and all purposes provided by law and persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Medford.
- SECTION 3: <u>Zoning Classification</u>. Upon recommendation of the Plan Commission, the territory annexed to the City of Medford by this ordinance is permanently designated to be a part of the C 1 "Commercial" Zoning District, for zoning purposes and subject to all provisions of the City of Medford Zoning Code.
- SECTION 4: <u>Ward Designation.</u> The territory described in Section 1 of this ordinance is hereby made a part of the Second District of the City of Medford, subject to the ordinances, rules and regulations of the City governing wards.
- SECTION 5: <u>Severability.</u> If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.
- SECTION 6: <u>Effective Date.</u> This ordinance shall take effect upon passage and publication as provided by law.
