

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF EAU CLAIRE THE CITY COUNCIL OF THE CITY OF EAU CLAIRE DO ORDAIN AS FOLLOWS:

SECTION 1. Territory Annexed. In accordance with Section 66.021 of the Wisconsin Statutes the following described territory in the Town of Seymour, Eau Claire County, Wisconsin, is annexed to the City of Eau Claire, Wisconsin:

> That part of the $SW_{\overline{u}}^{1}$ of the $SW_{\overline{u}}^{1}$, Section 10 T 27 N, R 9 W, Town of Seymour, Eau Claire County, Wisconsin described as follows:

Commencing at the Southwest corner of Section 10; thence East along the South line Section 10, 826.98 feet to the East R/W line Brookline Avenue as platted in Seymour Park Addition; thence North along the East R/W line Brookline Avenue 1312.33 feet to the North line of the SW SW Section 10; thence West 818.06 feet along said North line of the SW SW SW SW to the NW corner thereof; thence South along the West line said $SW_{\mu}^{\frac{1}{2}} SW_{\mu}^{\frac{1}{2}}$ 1313.40 feet to the point of beginning.

- SECTION 2. Effect of Annexation. - SECTION 3. Temporary Zoning Classification. The territory annexed to the City of Eau Claire by this ordinance is temporarily designated to be part of an R-lA (One Family Dwellings-Large Lots) District for zoning purposes and subject to all provisions of the Zoning Ordinance of the City of Eau Claire relating to such district classification and to zoning in the city.
- SECTION 4. School Purposes. The annexed territory is also annexed for school purposes and is thereby made a part of the city school district and subject to all of the laws governing the same.
- SECTION 5. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the 11th Ward of the City of Eau Claire, subject to all ordinances, rules and regulations of the City governing wards.
- SECTION 6. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or applications.


