AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF EAU CLAIRE
THE CITY COUNCIL OF THE CITY OF EAU CLAIRE DO ORDAIN AS FOLLOWS:

Section 1. Territory Annexed. In accordance with Section 66.021 of the Wisconsin Statutes, the following described territory in the Town of Seymour, Eau Claire County, Wisconsin, is annexed to the City of Eau Claire, Wisconsin:

That part of the  $SW_4^1-NE_4^1$ , Section 10, T 27 N, R 9 W, Town of Seymour, Eau Claire County, Wisconsin, described as follows:

Beginning at the Southeast corner of Powell's First Addition, on the East line of Gooder Street; thence Easterly along the South line Statz Country Addition to the East line of the SW4-NE4 Section 10; thence Southerly along said East line 178.00 feet; thence Westerly 567.00 feet parallel said South line Statz Country Addition, and the South line Block 3, Powell's First Addition; thence Northerly 178.00 feet to the South line Block 3, Powell's First Addition; thence South line Block 3, Powell's First Addition; thence Easterly along said South line to the point of beginning.

Section 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be part of the City of Eau Claire for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Eau Claire.

Section 3. Temporary Zoning Classification. The territory annexed to the City of Eau Claire by this ordinance is temporarily designated to be R-1 One-Family Dwelling District for zoning purposes and subject to all provisions of the Zoning Ordinance Preceived AND FILED

of the City of Eau Claire relating to such district classification and to zoning in the city.

Section 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the 11th Ward of the City of Eau Claire, subject to all ordinances, rules and regulations of the City governing wards.

Section 5. Severability. If any provision of this ordinances is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or applications.

. <u>Section 6</u>. This ordinance shall take effect upon passage and publication as provided by law.


