AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF APPLETON, WISCONSIN. (Siekman Annexation)

Section 1. <u>Territory Annexed</u>. In accordance with Section 66.021 of the Wisconsin Statutes for 1985, the following described territory in the Town of Harrison, Calumet County, Wisconsin, lying contiguous to the City of Appleton is hereby annexed to the City of Appleton, Wisconsin.

Part of the Northeast 1/4 of the Northeast 1/4 of Section 7, and Northwest 1/4 of the Northwest 1/4 of Section 8, Town 20 North, Range 18 East, Town of Harrison, Calumet County, Wisconsin, more fully described as follows: Beginning at the Northeast corner of said Section 7; thence S89°-59'-35" E along the North line of Section 8, a distance of 33.00 feet to the East right-of-way line of Kernan Avenue; thence S 00°-31'-35" W, along the said East right-of-way line, 247.68 feet; thence S 63°-53'-21" E, 102.32 feet to a point on the Northwesterly right-of-way line of C.T.H. "P" (Plank Road); thence S 43°-17'-22" W, 233.15 feet to a point at the intersection of the West line of Kernan Avenue and the Northwesterly right-of-way line of C.T.H. Section 4. Zoning. The territory described in Section 1 is hereby zoned as follows: R-lA (One Family Residential District).

Section 5. <u>Severability</u>. If any provisions of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.
