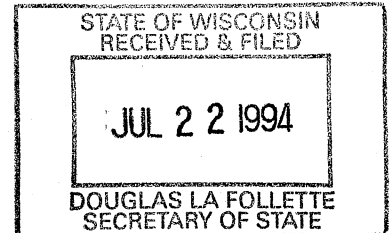

The Common Council of the City of Appleton do ordain as
follows:

Section 1. Territory Annexed. In accordance with Section 66.021
of the Wisconsin Statutes for 1991-1992, the following described
territory in the Town of Menasha, Winnebago County, Wisconsin,
lying contiguous to the City of Appleton, is hereby annexed to the
City of Appleton, Wisconsin.

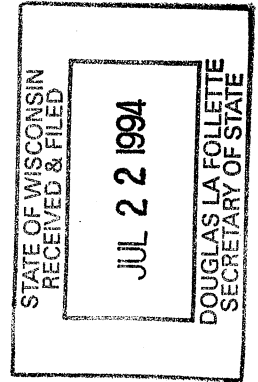
Part of the Northwest 1/4 of the Southeast 1/4, Section
1, T20N, R17E, Town of Menasha, Winnebago County,
Wisconsin, described as follows: Commencing at the
Center 1/4 corner of said Section 1; thence South 00
degrees 02 minutes 12 seconds West 297.00 feet, along
the West line of said Southeast 1/4, to the point of
beginning; thence continuing South 00 degrees 02 minutes
12 seconds West 215.39 feet; thence South 88 degrees 41
minutes 34 seconds East 340.00 feet; thence North 01
degrees 24 minutes 48 seconds East 511.84 feet; thence
North 88 degrees 41 minutes 34 seconds West 91.44 feet;
thence 101.23 feet on an arc of a curve to the right
having a radius of 216.00 feet and whose chord bears
South 72 degrees 51 minutes 43 seconds West 100.31 feet;
thence South 00 degrees 02 minutes 12 seconds West
264.83 feet; thence North 88 degrees 41 minutes 34
seconds West 165.01 feet to the point of beginning,
containing 2.900 acres.

This parcel lies within the Town of Menasha, Winnebago County,
Wisconsin.

Section 2. Effect of Annexation. From and after the date of this
Ordinance the territory described in Section 1 shall be a part of
the City of Appleton for any and all purposes provided by law and
all persons coming or residing within such territory shall be
subject to all ordinances, rules and regulations governing the
City of Appleton.

Section 3. Ward Designation. The territory described in Section 1 of this Ordinance is hereby made a part of the Forty-Ninth (49th) Ward attached to the Eighth (8th) Aldermanic District of the City of Appleton, subject to the ordinances, rules and regulations of the City governing Wards.

Section 4. Zoning. The territory described in Section 1 is hereby temporarily zoned as follows, pursuant to Section 66.021(7)(a), Stats.




PD - R-3 (Planned Development Overlaying Multi-Family Residential District)

PD - C-2 (Planned Development Overlaying General Commercial District)

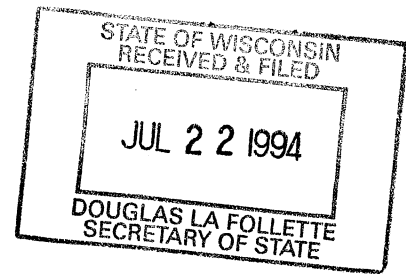
Section 5. Severability. If any provisions of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date. This Ordinance shall take effect upon passage and publication.

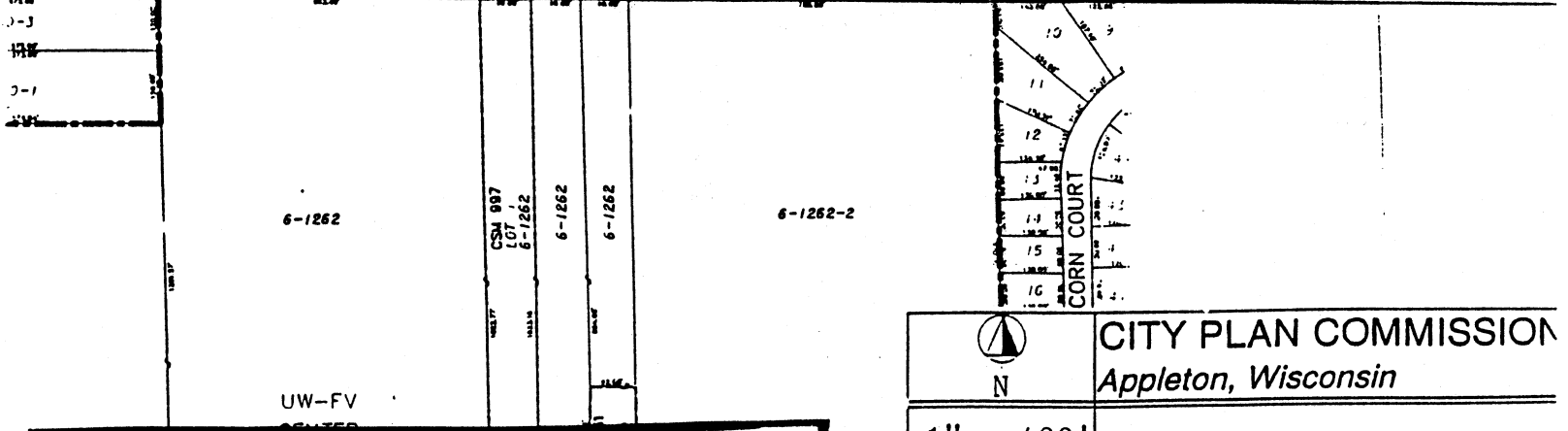
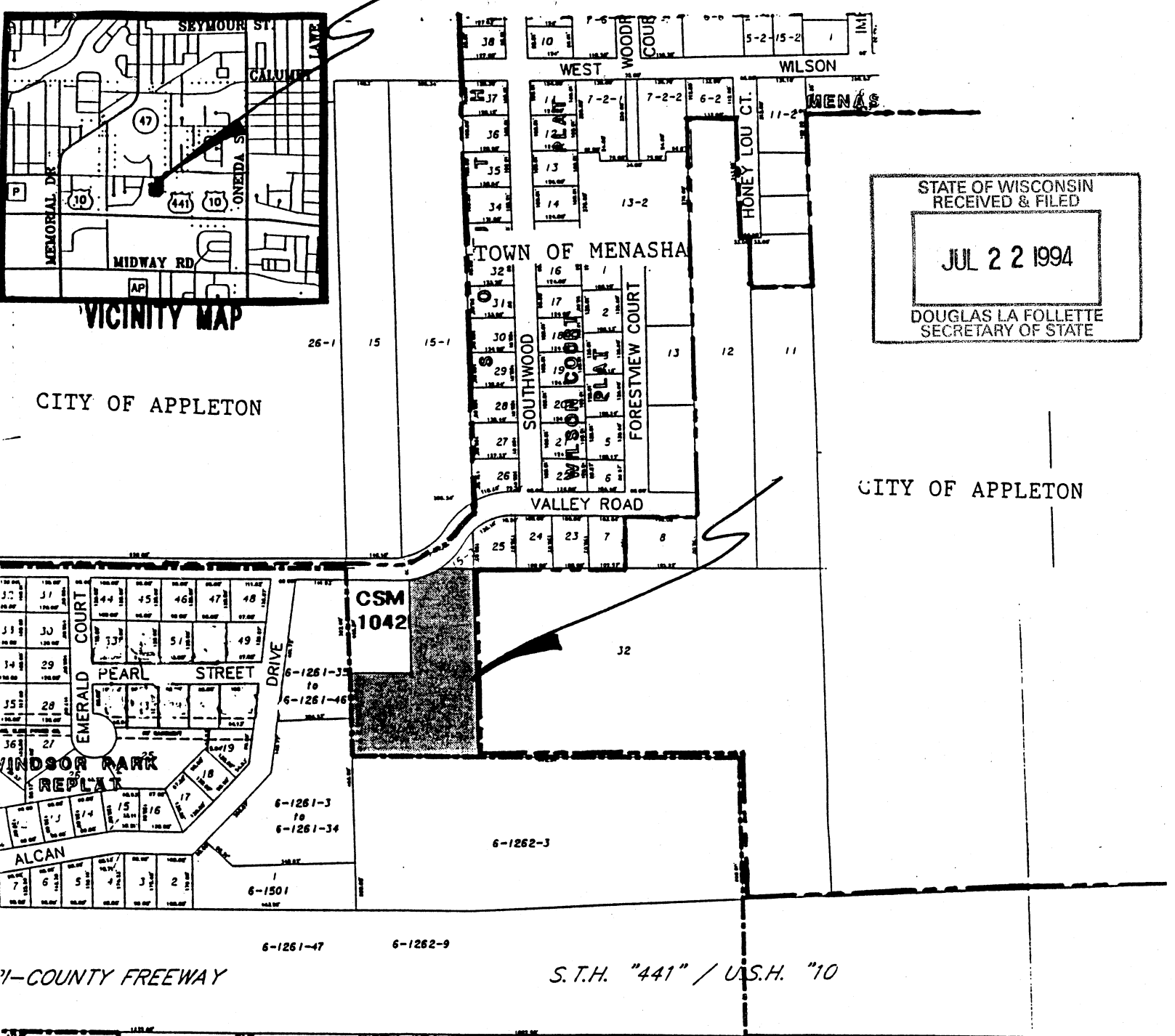


VICINITY MAP
