I, W. L. Kerr, being the duly elected, qualified, and acting City Clerk of the City of Green Bay, Wisconsin, hereby certify that upon the petition of the number of electors required by law, the Mayor of the City of Green Bay called a special election, which election was held in all the wards and precincts of the said city, at the polling places in said wards and precincts, on the twenty-first day of February, 1916. At such election the question submitted was, "Shall the plan to reorganize the City of Green Bay, Wisconsin, under Sections 925M-301 to 925M-319 inclusive, of the Statutes and Acts, amendatory thereof, be adopted?"

I further certify that a call was issued by the Mayor of said City for a special meeting of the Common Council of the said City, to be held at the hour of eight o'clock P. M., on the twenty-fifth day of February, 1916, at the Council Chamber at the City Hall, for the purpose of canvassing the votes cast at the said election. That said meeting was held in accordance with the call issued by the Mayor and said vote was canvassed by the Council, the result declared as follows: There were 2240 votes cast for the adoption of the plan provided for in the said question submitted, and 2010 votes cast against the adoption of the plan as provided for in the said question submitted. That there was a majority of 230 votes cast in favor of the adoption of the plan to reorganize

the City of Green Bay, Wisconsin, under Sections 925M-301 to 925M-319 inclusive, of the Wisconsin Statutes.



TO WHOM THESE PRESENTS MAY COME, GREETING:

WHEREAS, it has been certified by the City Clerk of the City of Green Bay. Brown County, Wisconsin, which city is a city of the third class under special charter, to the Secretary of State, that sections 925m-301 to 925m-319, inclusive, of the statutes have been complied with in the following manner:

That a petition of electors of the number required by law to call a special election of the electors thereof for the purpose of voting upon the plan to reorganize the City of Green Bay under sections 925m-301 to 925m-319 was duly presented to the Mayor of the said City of Green Bay and duly signed, as provided by law; and

That on the twenty-first day of February, A. D. 1916, an election was held pursuant to a proclamation by the said Mayor. at which the following question was duly submitted to the voters, to-wit: "Shall the plan to reorganize the City of Green Bay, Wisconsin, under Sections 925m-301 to 925m-319, inclusive, of the Statutes and Acts amendatory thereof, be adopted?"

number of votes cast was 4,250 of which number 2,240 votes were cast in favor of the adoption of said sections and 2,510 were cast against the adoption of said sections, and that the adoption of the said sections was therefore declared by the common council to have been carried by a majority of 230 votes; and whereas, the said City Clerk of the City of Green Bay, Brown County, wisconsin, has further certified to the Secretary of State that all steps necessary to be taken as required by the statutes were duly had, and the election thereupon was duly conducted, and the votes duly canvassed, and the result duly declared as provided by law;



NOW THEREFORE, I. Emanuel L. Philipp. as Governor of the State of Wisconsin. by virtue of the authority in me vested by Section 925-5. Wisconsin Statutes, do declare by these LETTERS PATENT that the said City of Green Bay has adopted said Sections 925m-301 to 925m-319, inclusive, of the statutes; that the boundaries of the said city are defined to be those now established by law, and that said City is a body corporate and politic by the name of the City of Green Bay, and that the same shall be governed by the provisions of the general law aforesaid, and amendments thereof, applicable to said City of Green Bay, except as modified. limited or changed by the provisions of Sections 925m-301 to 925m-319, inclusive, of the statutes, relating to the organization and government of cities under a commission form of government.
