A charter ordinance amending Sections 2.01 and 2.02 of the Baraboo Municipal Code of Ordinances removing the office of City Treasurer as an elective office of the City of Baraboo and providing for the appointment of the City Treasurer by the Common Council of the City of Baraboo.

THE COMMON COUNCIL OF THE CITY OF BARABOO, WISCONSIN, DO ORDAIN AS FOLLOWS:

1. The City of Baraboo, pursuant to Section 62.09(3), Wisconsin Statutes, and 66.01, Wisconsin Statutes, hereby amends Sections 2.01 and 2.02 of the Baraboo Municipal Code of Ordinances to remove the office of City Treasurer as an elective office of the City of Baraboo and hereby elects not to be governed by those portions of Section 62.09(3), Wisconsin Statutes, which are in conflict with this ordinance, relating to the choosing of the City Treasurer by election of the voters.

2. Commencing on May 1, 1986, the office of the City Treasurer and the duties of the City Treasurer shall be performed by the person appointed as City Treasurer by the Common Council of the City of Baraboo.

3. The appointed City Treasurer shall hold office for an indefinite term subject to removal from office for cause pursuant to Section 17.12(1)(c), Wis. Stats.

4. The City Treasurer shall perform all duties required of the office of the City Treasurer as provided by law.

5. Any charter provision or any previously enacted ordinance or charter ordinance inconsistent or in conflict herewith is hereby expressly repealed.

6. This is a charter ordinance and shall take effect sixty days after its passage and publication unless within such sixty day period a referendum petition as provided by Section 66.01, Wis. Stats., shall be filed, in which event this ordinance shall not take effect until it shall have been submitted to a referendum vote of the electors and approved by a majority of the electors voting thereon.
