I hereby certify that the following Charter Ordinance, No. 1732, was read for the first time at a regular meeting of the Common Council of the City of Baraboo, on April 26, 1994.

It was moved by Alderperson Platt, seconded by Alderperson Hein and carried on roll call 8 ayes to 0 noes (1 absentee) that the Charter Ordinance take its regular course.

Charter Ordinance No. 1732 was read the second time at a regular meeting of the Common Council of the City of Baraboo on May 10, 1994.

It was moved by Alderperson Bidwell, seconded by Alderperson Hein and carried on roll call 9 ayes to 0 noes.

Said Charter Ordinance shall take effect 60 days after passage and publication, unless a referendum petition is filed within said 60 days, in which event this Charter Ordinance shall not take effect until it shall have been submitted to a referendum vote of the electors and approved by a majority of the electors voting thereon.

A Charter Ordinance making 1.04(4) and 1.05(2) of the Municipal Code of Ordinances as Charter Ordinances and thereby providing that all City officials appointed pursuant to s.1.03 of the Code may be removed from office for cause by a majority of all the members of the appointing body, except that where a City official is employed pursuant to a written employment contract, such official may be removed from office in accordance with the terms of the contract, and except that where a corporation or independent contractor is appointed as City Assessor the appointment shall be for a term of one year and may be renewed or terminated at any time at the pleasure of the Common Council by a majority of all members.

THE COMMON COUNCIL OF THE CITY OF BARABOO, WISCONSIN, DO ORDAIN AS FOLLOWS:

- 1. Section 1.04(4) is hereby created as a charter ordinance to read as follows:
 - "1.04. GENERAL PROVISIONS RELATING TO CITY OFFICIALS.
 - (4) REMOVAL FROM OFFICE. All City Officials appointed pursuant to s.1.03 of the Code may be removed from office for cause by a majority of all the members of the appointing body. A City official employed by the City pursuant to a written employment contract may be removed from office in accordance with the terms of the contract. The City Assessor may be removed from office as provided in s.1.05 of the Code.
- 2. Section 1.05(2) is hereby created as a Charter Ordinance to read as follows:
 - "1.05. CITY ASSESSOR TO BE INDEPENDENT CONTRACTOR.
 - (2) REMOVAL FROM OFFICE. If a corporation or independent contractor is appointed as the City Assessor the appointment shall be for a term of one year and the appointment may be renewed or terminated at pleasure at any time by a majority of all the members-elect of the Common Council."
- 3. Any charter provision or any previously enacted Ordinance or Charter Ordinance inconsistent or in conflict herewith is hereby expressly repealed.
- 4. This is a Charter Ordinance and shall take effect 60 days after its passage and publication unless within such 60 day period a referendum petition as provided by Section 66.01, Wis. Stats., shall be filed with the City Clerk, in which event this Ordinance shall not take effect until it shall have been submitted to a referendum vote of the electors and approved by a majority of the electors voting thereon.
