We, the undersigned, John Houwers Mayor, and A. L. Leavens, City Clerk, of the City of Sheboygan Falls, hereby certify that the following described territory has been attached to the Second Ward of the City of Sheboygan Falls, in said Sheboygan County, to-wit:

Commencing at the intersection of the West line of Section thirty-six (36), Town fifteen (15) North, Range twenty-two (22) East with the centerline of Pine Street in the City of Sheboygan Falls, Wisconsin, thence along said centerline South fifty-eight (58) degrees twelve (12) minutes West sixty and ninety-five one-hundredths (60.95) feet, thence North forty-six (46) degrees thirty-four (34) minutes West one hundred fifty and twenty-five one-hundredths (150.25) feet, thence North fifty-two (52) degrees fifteen (15) minutes East eighty (80) feet, thence North thirty-five (35) degrees forty-three (43) minutes East one hundred forty-five (145) feet, thence south, fifty-three (53) degrees, forty-five minutes East, three and seventy-five one-hundredths (3.75) feet, to a point in the West line of said section thirty-six (36), thence south to the point of beginning.

Commencing at the West quarter (1/4) corner of Section thirty-six (36), Town fifteen (15) North, Range twenty-two (22) East, running thence South one hundred fifty (150) feet, thence West one hundred twenty (120) feet, thence North one hundred fifty (150) feet, thence East one hundred twenty (120) feet to the point of beginning, containing forty-one one-hundredths (0.41) acres, and being a part of the Northeast quarter (1/4) of the Southeast quarter (1/4) of Section thirty-five (35), Town fifteen (15) North, Range twenty-two (22) East.

We further certify that more than ninety days have elapsed since the passage of the ordinance by the Common Council attaching said territory and that no petition has been presented to the Common Council asking that the question of annexation be submitted to the electors of the City.

We further certify that the ordinance attaching said territory were was passed in full compliance with Section 62.07 of the Wisconsin Statutes, and that all steps in connection with said annexation were taken in full compliance with the Statutes.

We further certify that the following is a description of the boundaries of the City of Sheboygan Falls after such alteration, to-wit:

Commencing at the intersection of the centerline of the Sheboygna Fond du Lac Plank Road with the East line of Section Twenty-five (25) Town fifteen (15) North, Range twenty-two (22) East, running thence South along the East line of Section twenty-five (25), and Section thirty-six (36), six thousand two hundred and twenty-four (6224) feet, to the Southeast corner of Section thirty-six (36), Town fifteen (15) North, Range twenty-two (22) East, running thence West along the South line of said Section thirty-six (36), five thousand two hundred and eighty (5280) feet to the Southwest corner of said Section, thence North One thousand five hundred ninety-four (1594) feet to the centerline of S.T.H. 28, thence along said centerline South fifty-eight (58) degrees, twelve (12) minutes West, sixty and ninety-five one hundredths (60.95) feet, thence North forty-six (46) degrees thirty-four (34) minutes West

one hundred fifty and twenty-five one-hundredths (150.25)
feet, thence North fifty two (52) degrees fifteen (15) minutes
East, eighty (80) feet, thence North thirty-five (35) degrees
forty-three (43) minutes East, one hundred forty-five (145) feet,
thence South fifty three (52) degrees forty-five (145) minutes thence South fifty-three (53) degrees forty-five (45) minutes East, three and seventy-five one-hundredths (3.75) feet, thence North along the West line six hundred seventy-six and eightyseven one-hundredths (676.87) feet, thence West one hundred twenty (120) feet, thence North one hundred fifty (150) feet to a point in the East and West quarter (1/4) Section line of Section thirty five (35), thence West along said line two hundred seventy-four and five-tenths (274.5) feet, thence North one thousand one hundred and forty five (1145) feet to a point in the centerline of the Sheboygan River five hundred ninetyfive (595) feet, thence North thirty-two (32) degrees, zero (0) minutes west, five hundred seventy (570) feet, thence West One thousand four hundred eighty (1480) feet to a point in the North and South one-quarter (1/4) line of Section thirty-five (35), thence North along the North and South one-quarter (1/4) line through Sections thirty five (35) and twenty-six (26), one thousand four hundred ten (1410) feet to the centerline of the Sheboygan-Fond du Lac Plank Road, thence Easterly along the centerline of the above road, two thousand seven hundred twenty-five (2725) feet to the intersection of said centerline with the West line of Section twenty-five (25), Town fifteen (15) North, Range twenty-two (22) East, running thence North along the West line of Section twentyfive (25), eight hundred forty (840) feet, thence East five thousand two hundred eighty (5280) feet to a point in the East line of Section twenty-five (25), thence South along said East line three hundred ninety five (395) feet to the point of beginning, containing nine hundred twelve and twenty-six one hundredths (912.26) acres, or 1.425 square miles.
