that the following described territory was detached from the  
Town of Hartford, County of Washington, and was annexed to  
the said City of Hartford pursuant to Section 66.021 of the  
Wisconsin Statutes, by an Ordinance adopted by the Common  
Council at a regular meeting held July 21, 1964:

That part of the Northeast One Quarter of the Southwest  
One Quarter (NE $\frac{1}{4}$  SW $\frac{1}{4}$ ) of Section Seventeen (17),  
Township Ten (10) North, Range Eighteen (18) East, Town  
of Hartford, Washington County, Wisconsin, and described  
as follows:

Commencing at the South One Quarter corner, Section  
Seventeen (17), Township Ten (10) North, Range Eighteen  
(18) East, thence North 00 degrees 59 minutes East on  
the South One Quarter line of said Section 1807.40 feet,  
thence North 80 degrees 30 minutes West on a line common  
to the City of Hartford 636.03 feet to the point of  
beginning of this description. Thence continuing North  
80 degrees 30 minutes West on line common to the City of  
Hartford 696.09 feet, thence North 00 degrees 59 minutes  
East on the center line of C. T. H. "U" 318.59 feet,  
thence South 88 degrees 37 minutes East, 688.42 feet,  
thence South 00 degrees 59 minutes West, 416.79 feet to  
the point of beginning of this description.

Said parcel contains 5.81 acres.



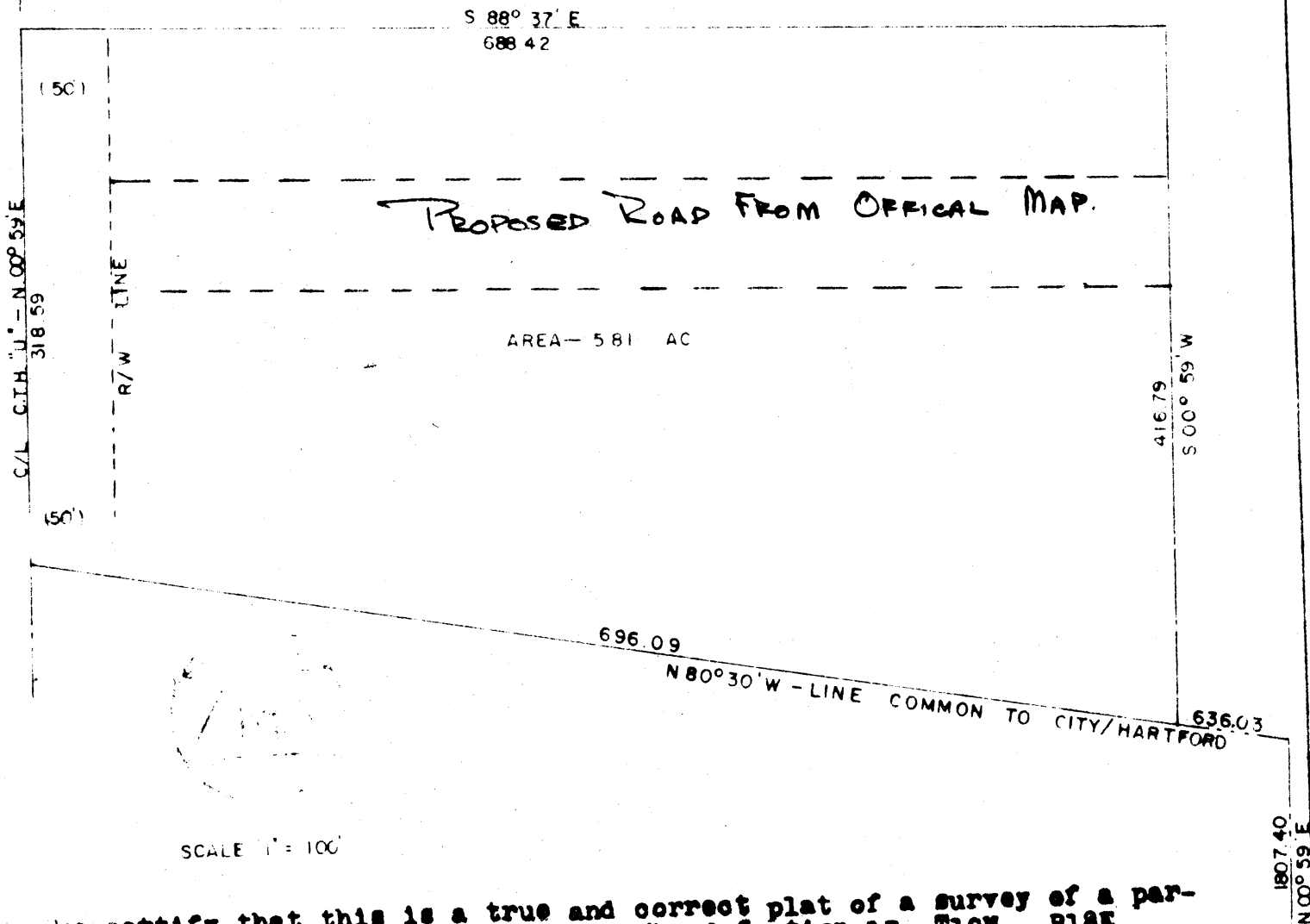
