

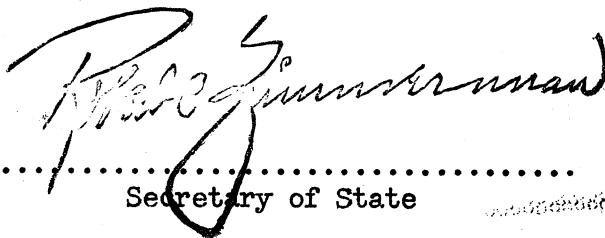

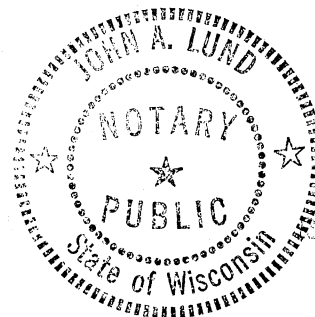

Commencing at the N.W. corner of the S.E. $\frac{1}{4}$, N.E. $\frac{1}{4}$, Section 21, Town 41 N., Range 9 W; thence Easterly on the 1/16th line to its intersection with the N.S. $\frac{1}{4}$ line, Section 22; thence Southerly on said $\frac{1}{4}$ line to the S.W. corner of the N.W. $\frac{1}{4}$, S.E. $\frac{1}{4}$, Section 22; thence Easterly on the 1/16th line to the S.E. corner of the N.W. $\frac{1}{4}$ S.E. $\frac{1}{4}$, Section 22; thence Southerly on the 1/16th line to the Section line dividing Sections 22 and 27; thence Easterly on said Section Line to the N.E. corner of the N.W. $\frac{1}{4}$; N.W. $\frac{1}{4}$, Section 26; thence Southerly on the 1/16th line to the E.W. $\frac{1}{4}$ line of Section 26; thence Westerly on said $\frac{1}{4}$ line to its intersection with the $\frac{1}{4}$ lines of Section 27; thence Southerly on the N.S. $\frac{1}{4}$ line, Section 27 to the N.E. corner of the S.E. $\frac{1}{4}$; S.W. $\frac{1}{4}$, Section 27; thence Westerly on the 1/16th line to the N.E. corner of the S.E. $\frac{1}{4}$; S.E. $\frac{1}{4}$; Section 28; thence Southerly on the Section Line dividing Sections 28 and 27 to the S.E. corner of Section 28; thence Westerly on the Section Line dividing Sections 28 and 33 to the East R/W line of S.T. Hwy. 27; thence North-easterly on said R/W line to a point which intersects an East West line parallel to and 400 feet Northerly of the E.W. 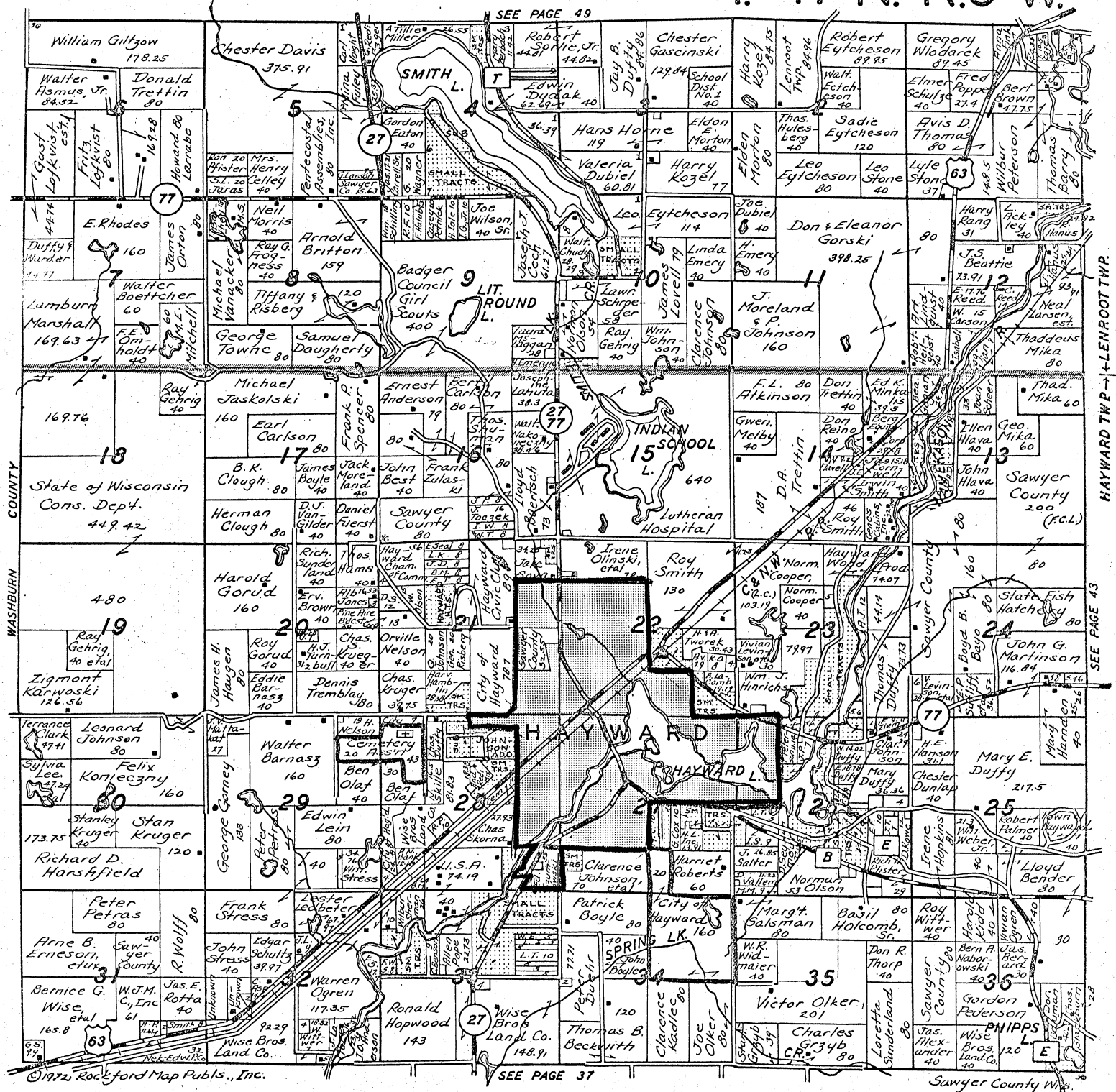
