ORDINANCE #82 - 24

AN ORDINANCE ANNEXING TERRITORY FROM THE TOWN OF LAWRENCE TO THE CITY OF DE PERE, BROWN COUNTY, WISCONSIN

WHEREAS, a petition has been filed with the Clerk-Treasurer of the City of De Pere requesting the annexation of the herein-after described territory, heretofore located in the Town of Lawrence, Brown County, Wisconsin, to the City of De Pere, Brown County, Wisconsin pursuant to Section 66.021 (12), Wisconsin Statutes.

AND WHEREAS, the Common Council finds that the hereinafter described territory is contiguous to the City of De Pere, that the petition for annexation herein is a petition for direct annexation; that the petitioner constitutes the owner of all the real property in such territory and that no electors reside in such territory; that the procedural requirements of Section 66.021, Wisconsin Statutes, have been complied with; and that such annexation is not against the public interest.

NOW, THEREFORE, the Common Council of the City of De Pere, Wisconsin, do ordain as follows:

<u>Section 1</u>. That the Common Council accepts such annexation petition; that the following described territory, now located in the Town of Lawrence, Brown County, Wisconsin, to wit:

All that part of U.S. Highway 41 right of way lying within Private Claim 29, west side of Fox River, Section 20, 29 and 30, all in Township 23 North, Range 20 East, bounded on the north by the north line of Lot 104, Assessor's Subdivision of 1925 of lands in the City of Nicolet, bounded on the south by the centerline of County Trunk Highway "F" (Scheuring Street), bounded on the west by the centerline of U.S. Highway 41 and bounded on the east by the east right of way line of U.S. Highway 41 (existing city limits of the City of De Pere) all such property located in the Town of Lawrence, Brown County.

be and the same is hereby annexed to and made a part of the City of De Pere, Brown County, Wisconsin. That attached hereto, and identified as Exhibit "A", is a scale map of the boundaries of the territory annexed herein.

Section 2. That the above described territory lying south of the centerline of Grant Street (CTH EE) is hereby made a part of Third Aldermanic District, Seventh Ward of the City of De Pere, and the above described territory lying north of the centerline of said street is hereby made a part of the Fourth Aldermanic District, Ninth Ward of the City of De Pere. All such annexed territory shall be a part of the City of De Pere for any and all purposes provided by law and shall be subject to all laws, ordinances, rules and regulations of the City of De Pere applicable thereto.

Section 3. That the above described annexed property prior to such annexation was a part of the School District of West De Pere and such territory shall remain a part of said School District of West De Pere and shall continue to be subject to the laws governing said School District.

Section 4. That the property annexed hereto shall be temporarily classified as R-l Residence Zoning District Classification. The issue of permanent classification of the above described territory for zoning purposes is hereby referred to the City Plan Commission for its study and recommendation, and permanent zoning thereof shall be established by a separate zoning ordinance enacted pursuant to the requirements of Section 62.23 (7)(d), Wisconsin Statutes.

Section 5. That upon adoption of this Ordinance, the Clerk-Treasurer shall file a certified copy of this Ordinance and a certificate of annexation and scale map of the property annexed with the Secretary of State, with any utility company

currently providing service to such area, with the Register of Deeds for Brown County, and with the Clerk of the School District of West De Pere in accordance with Section 66.021 (8), Wisconsin Statutes; and further, said Clerk-Treasurer shall give written notice of the acceptance of such annexation petition to the Clerk of the Town of Lawrence by personal service or by registered mail with return receipt requested.

Section 6. That this Ordinance shall be in full force and effect from and after its passage and publication according to law.
