## CERTIFICATE FOR REPORTING CORPORATE LIMITS

## OF CITY OR VILLAGE AFTER ALTERATION

I, Harriet M. Wollitz, City Clerk of the City of Lake Mills, County of Jefferson, State of Wisconsin, DO HEREBY CERTIFY that the corporate boundaries of the said City of Lake Mills have been altered within the previous 12-month period ending December 1, 1964, and that the following description is the present corporate limits of the said City of Lake Mills as of December 1, 1964:

Partof Township Seven (7) North, Range Thirteen (13) East, Town of Lake Mills, and part of Section Eighteen (18), Township Seven (7) North, Range Fourteen (14) East, Town of Aztalan, Jefferson County, Wisconsin:

Commencing at the East quarter corner of Section 12, Township 7 North, Range 13 East (said quarter corner is the Northeast corner of city limits); thence South one-half mile to the Southeast section marker of Section 12 in said township; thence South 1060.3 feet to a point in the centerline of C.T.H. 'B"; thence South 79° 18' E., along said centerline 161.01 feet; thence South 20° 59' West 236.77 feet; thence South 33° 29' East 1041.77 feet; thence South 0° 39' West 1794.22 feet; thence North 88° 27' 40" West 654.4 feet to a point on the East section line of Section 13, Township 7 North, Range 13 East; thence North 89° 18' West 1317.67 feet; thence North 6° 54' 50" West 1334.53 feet to a point on the East-West one-quarter section line of Section 13 in said township; thence West along said one-quarter sectionline 3766 feet to a point (said point is 198 feet East of the centerline of South Main Street); thence South 540 feet; thence East 1368.8 feet; thence South 800.53 feet; thence West 1372.26 feet; thence South 2138.72 feet; thence West 165 feet; thence South 82.5 feet; thence 550 feet West; thence North 916.41 feet to a point on the South section line of Section 13, Township 7 North, Range 13 East; thence South 88° 55' West, along said Section line 955 feet; thence North 1° 27' East 125.0 feet; thence South 88° 55' East 66 feet; thence North 1° 27' West 141.55 feet; thence North 77° 24' West 33.03 feet to a point in the centerline of South Ferry Drive; thence in a northerly direction one-half mile, more or less, following the centerline of South Ferry Drive to a point on the East-West one quarter section line of Section 14, Township 7 North, Range 13 East; thence West along said one-quarter section line 415 feet, more or less, to the East shore of Rock Lake; thence in a northerly direction along lake shore one mile, more or less, to the East-West one-quarter section line of Section 11, Township 7 North, Range 13 East; thence in a northerly direction along lake shore 210 feet, more or less to a point; thence East 305.5 feet; thence South 210 feet to the East-West one-quarter section line of Section 11, Township 7 North, Range 13 East, thence East along said one-quarter section line to a point in the center line of Pine Street 545.2 feet West of the East quarter corner of Section 11, Township 7 North, Range 13 East; thence North 5° 53' East, 25 feet; thence North 86° 53' West 82.5 feet; thence North 5° 53' West 165 feet; thence North 87° 03' West 388 feet; thence North 5° 53' West 241.3 feet; thence North 87° 03' West 120 feet; thence North 0° 45' West 211.85 feet; thence South 87° 03' East 689.5 feet; thence North 19° 05' East 408 feet; thence North 70° 21' East 613 feet; thence South 19° 20' West 472.12 feet; thence South 19° 36' West 415.74 feet to a point on the East-West one-quarter section line of Section 12, Township 7 North, Range 13 East (said point is 11.6 feet East of the West quarter corner of Section 12); thence East along said one-quarter section line one mile, less 11.6 feet, to the point of beginning.

Commencing in the center of the road leading from the village of Lake Mills to the head of Rock Lake at the northeast corner of a lot of land deeded by Allanson Farmer to Mrs. Comrad, being part of the northeast fractional quarter (NEZ) of Section Eleven (11), Township Seven (7) North of Range Thirteen (13) East running thence north twenty-five degrees (25°) west in the center of said road, fifteen (15) chains and ten (10) links, thence north, three degrees (3°) west, along said road four (4) chains fifteen links (15), thence north, sixty degrees (60°) west, in said road three (3) chains eighteen (18) links to the southerly line of a lot of land heretofore deeded by said Farmer to Reynolds, thence south, fifteen degrees (15°) west, along the line of said land, five (5) chains fifty (50) links to the bank of the lake, thence southerly along the bank of the lake, eleven (11) chains sixty-eight (68) links to the north line of the aforesaid Mrs. Comrad's land, thence east nine (9) chains fifty (50) links to the place of beginning containing eleven (11) acres of land according to the survey of J. D. Waterbury of August 15, 1874.

Also the following described land commencing on the north bank of said Rock Lake one (1) chain thirty (30) links easterly from where the north and south line strikes the north bank of said lake, thence running north, thirty degrees (30°) east, one (1) chain and fifty (50) links, thence south seventytwo and one-half degrees (72 $\frac{1}{2}$ °) east, three (3) chains and ninety-two (92) links, thence south ten and one-half degrees ( $10\frac{10}{2}$ ) west, seven (7) chains fifty (50) links to the bank of said lake, thence north, twenty-five degrees (25°) west along the bank of said lake, seven (7) chains and ninety (90) links to the place of beginning, containing one and eighty-nine one hundredths (1.89) acres more or less magnetic variation six degrees (6°) forty-five (45) minutes east. Also beginning at a post on a line of fence south seventy-four degrees twenty minutes (74° 20') east three (3) chains and fifty-two (52) links from a point on the quarter line that runs north and south through Section two (2), Township Number seven (7) North Range thirteen (13) east, said point being four (4) chains ten (10) links north from highwater mark on Rock Lake, thence from place of beginning south seventy-four degrees and twenty minutes (74° 20') east two (2) chains and seventeen (17) links, thence south, forty-nine degrees (49°), thirty minutes (30') east, three (3) chains, fifty-two (52) links, thence south, thirty-six degrees and forty-five minutes (36° 45') west, four (4) chains twenty-five (25) links, thence north, nine degrees and thirty minutes (9° 30') east, two (2) chains, thirty-four (34) links, thence north, seventy-one degrees, fifteen minutes (71° 15') west, three (3) chains ninety (90) links, thence North, twenty-one degrees thirty minutes (21° 30') East, two (2) chains and eighty-nine (89) links to place of beginning, containing one (1) acre and eighty-two (82) square rods of land. All of the above land being in the Town of Lake Mills, Jefferson County, Wisconsin.
