

## AN ORDINANCE

The Common Council of the City of Wausau do ordain as follows:

Section 1. Pursuant to the authority granted in Section 62.09 (5), Wisconsin Statutes, the term of the mayor shall from and after the third Tuesday in April, 1964, be for a duration of four years.

Section 2. Section 2.01 (1) of the Wausau Municipal Code is hereby repealed and recreated to read as follows:

2.01 Elected Officials. (1) Mayor. There shall be a mayor who shall be elected at the regular city election for a term of four years commencing on the 3rd Tuesday of April, 1964.

Section 3. This charter ordinance shall be in full force and take effect sixty days after its passage and publication as provided in Section 66.01, Wisconsin Statutes.
