

AN ORDINANCE

The Common Council of the City of Wausau do ordain as follows:

Section 1. Pursuant to authority granted in Section 62.09(1), Wisconsin Statutes, Section 2.01(2) of the Wausau Municipal Code is amended to read as follows:

(2) COMMON COUNCIL. There shall be one alderman - supervisor from each ward who shall be elected at the regular city election for a term of 2 years commencing on the 3rd Tuesday of April in the year of their election.

Section 2. This charter ordinance shall be in full force and effect in accordance with Section 66.01, Wisconsin Statutes, sixty days after its passage and publication.
