

### AN ORDINANCE

The Common Council of the City of Wausau, Wisconsin, do ordain as follows:

Section 1. Territory Annexed. In accordance with Chapter 66, Wisconsin Statutes (1973), and the petition for unanimous direct annexation signed by John Schauss, Jr. and Lydia Schauss, sole owners of the land within the territory described below, now located in the Town of Wausau, Marathon County, Wisconsin, is hereby annexed to the City of Wausau:

Maple Hill Addition to Arnold Taschler Subdivision, except Lot 165 thereof, and 60 feet South and adjacent to Lot 165, and also except the North 180.00 feet of said Addition.


- Section 2. Effect of Annexation. From and after the date of publication of this ordinance the territory described in Section 1 shall be a part of the City of Wausau, for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Wausau.
- Section 3. Zoning Classification. Zoning of the within lands shall be pursuant to sec. 23.04.040, Zoning of Annexed Lands, of the Wausau Municipal Code. Upon recommendation of the Planning Commission and Zoning, Annexation & Industrial Park Committee the annexed territory shall be designated as a temporary R-3 zone.
- Section 4. Aldermanic District. The territory described in Section 1 of this ordinance is hereby made a part of the Seventh Aldermanic District of the City of Wausau, subject to the ordinances, rules and regulations of the city governing districts.

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date. This ordinance shall take effect upon passage and publication, as provided by law.






