

AN ORDINANCE

The Common Council of the City of Wausau do ordain as follows:

Section 1. Territory Annexed. In accordance with Chapter 66, Wisconsin Statutes, and the petition for annexation signed by Alice M. Luedtke nee Alice M. Effa, sole owner of the land within the territory described below, now located in the Town of Wausau, Marathon County, Wisconsin, is hereby annexed to the City of Wausau:

That part of the Southwest quarter (SW 1/4) of the Northeast quarter (NE 1/4) of Section thirty (30), Township twenty-nine (29) North, Range eight (8) East, described as follows:

Beginning at a point 20 feet South and 160 feet East of the Northwest corner of said SW 1/4 of NE 1/4; thence South 672 feet to the North boundary line of Stark Street; thence East, on the North boundary line of Stark Street, 80 feet; thence North, parallel to quarter section line, 672 feet; and thence West 80 feet to the point of beginning.

Section 2. Effect of Annexation. From and after the date of publication of this ordinance, the territory described in Section 1. shall be a part of the City of Wausau, for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Wausau.

Section 3. Zoning Classification. Zoning of the within lands shall be pursuant to sec. 23.04.040, Zoning of Annexed Lands, of the Wausau Municipal Code.

Section 4. Aldermanic District. The territory described in Section 1. of this ordinance is hereby made a part of the Seventh Aldermanic District of the City of Wausau, subject to the ordinances, rules and regulations of the city governing districts.

Section 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.

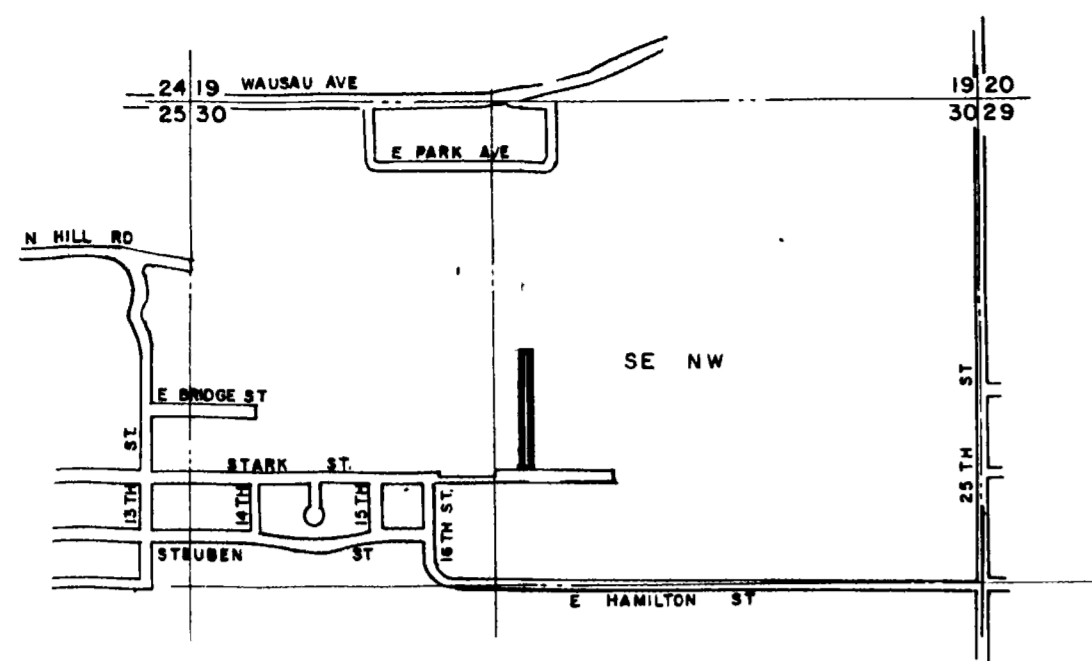

BE IT RESOLVED that the proposed Ordinance No. 497-771 attached hereto be enacted by the Common Council.

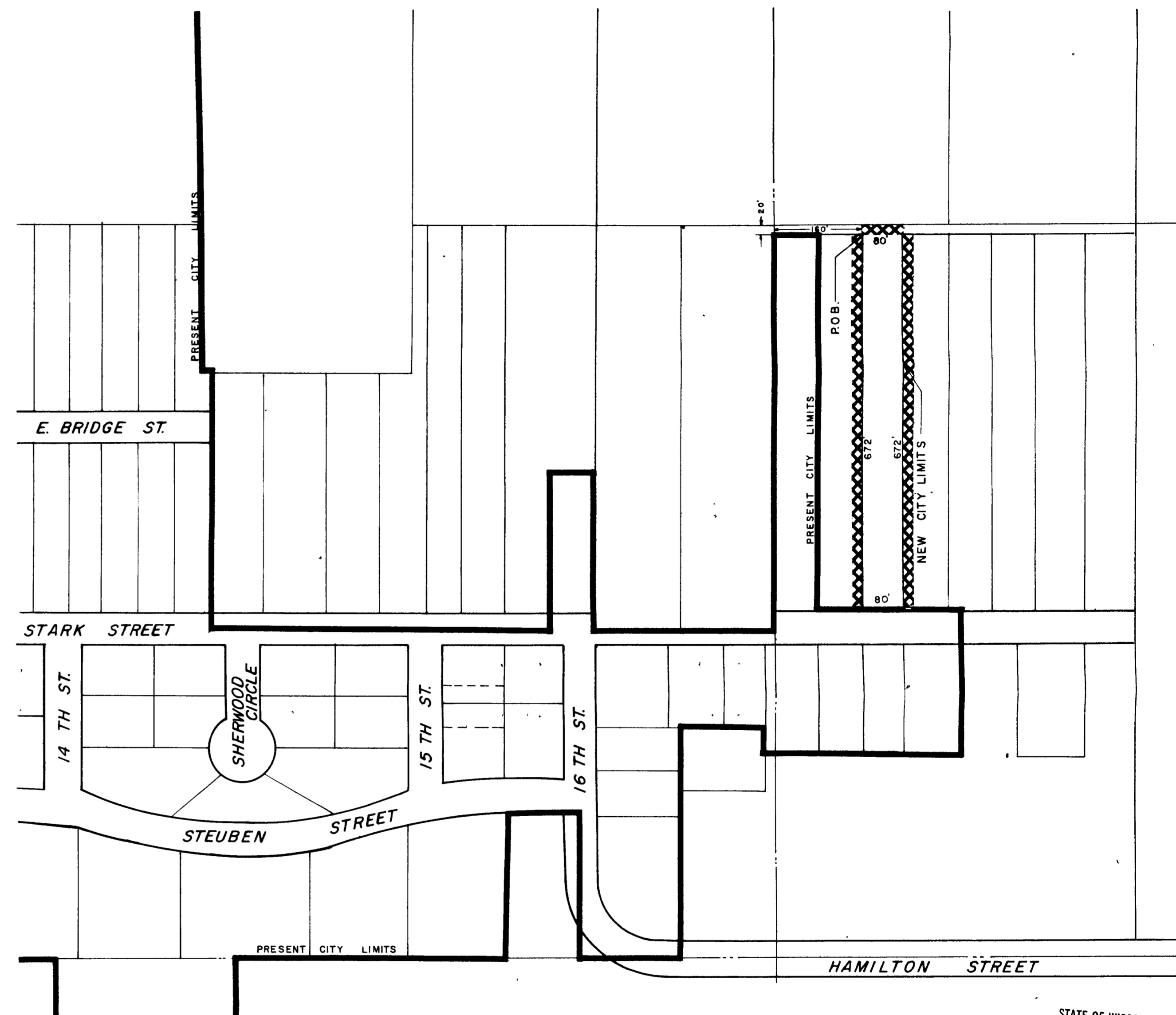
