NOW COME the plaintiffs, William C. Muth and Francis C.
Muth, by their attorneys, NASH, SPINDLER, DEAN & GRIMSTAD, and by
way of complaint against the defendant, City of Manitowoc, Wisconsin,
respectfully allege as follows:

- 1. Plaintiff, William C. Muth, is an adult resident of the City of Manitowoc, Manitowoc County, Wisconsin.
- 2. Plaintiff, Francis C. Muth, is an adult resident of the Town of Manitowoc, Manitowoc County, Wisconsin.
- 3. Defendant, City of Manitowoc, Wisconsin is a municipal corporation organized and operated under the laws of the State of Wisconsin and is located in the County of Manitowoc, Wisconsin.
- 4. Plaintiffs are informed and do believe that on or after the 2nd day of June, 1980, the defendant, City of Manitowoc, Wisconsin, by its duly elected representatives, did adopt an Annexation Ordinance, a true copy of which is marked Exhibit "A", attached hereto and made part hereof. A true copy of the Certificate of Annexation is marked Exhibit "B", attached hereto and made part hereof.

- 5. Said Annexation Ordinance purports to annex to defendant, City of Manitowoc, Wisconsin, certain real property more specifically described in said Annexation Ordinance and Certificate of Annexation. Substantial portions of said real property were and are, at all times relevant hereto, owned by plaintiffs above named.
- 6. Your plaintiffs did not petition for said annexation; nor did your plaintiffs support, sign, affirm or join in any petition for said annexation.
- 7. Defendant, City of Manitowoc, Wisconsin, by its duly elected representatives, did exceed its statutory and common law authority by acting in an arbitrary and capricious manner in adopting said annexation ordinance, in that said defendant, among other things:
 - Did, through its representatives, agents and employees, design and fix the shape and boundaries of said annexation, arbitrarily and capriciously, solely to insure its success;
 - 2) Has no reasonable present or demonstrable future need for said annexed real property or a substantial portion thereof;
 - and employees, abused its discretion in adopting said ordinance when it knew or should have known that the annexation is against the public interest and is opposed by property owners owning a substantial portion of the real property contained therein.

WHEREFORE, plaintiffs demand judgment against the

defendant as follows:

- 1. Declaring said Annexation Ordinance void and unenforceable from the date of its adoption or purported adoption;
- 2. For their costs and disbursements;
- 3. For such other and further relief as the Court deems just and equitable.

ORDINANCE

An Ordinance annexing certain territory to the City of Manitowoc and the 2nd and 8th Aldermanic Districts of said City.

The Mayor and Common Council of the City of Manitowoc do ordain as follows:

Section 1: Territory Annexed. In accordance with Section 66.021(12) of the Wisconsin State Statutes and Petition for Direct Annexation filed with the City Clerk April 21, 1980, signed by a majority of the owners of real property in assessed value and a majority of the qualified electors residing within the territory in the Town of Manitowoc, Manitowoc County, Wisconsin, the following described area is herewith annexed to the City of Manitowoc.

DESCRIPTION

A parcel of land located in the NE 1/4, Section 18, T. 19 N.,
R. 24 E., the North 1/2 of the NW 1/4, Section 17, T. 19 N., R. 24 E.,

Section 2: Effects of Annexation: The day after the publication of this ordinance the territory described in Section 1 shall be a part of the City of Manitowoo for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all ordinances, rules, regulations governing the City of Manitowoo, and the territory is annexed for school purposes and shall be under the Manitowoo Public School District and subject to all laws concerning the same.

Section 3. Aldermanic District Designation: The territory herein described is made a part of and attached to the 2nd and 8th Aldermanic Districts of the City of Manitowoc, with the boundaries being North 8th Street and North 18th Street.

Section 4. Zone District Classifications: The territory herein described is classified as "R-1" Residential-Agricultural District all as per Section 15.03 of the Municipal Code.
