

An Ordinance to annex certain territory from the Town of Newton to the City of Manitowoc as part of the 9th Aldermanic District and the 5th, 6th, 23rd and 29th

WHEREAS, the petition to annex the territory described below has been filed with the City of Manitowoc; and

WHEREAS, the petition meets the requirements of Wisconsin Statute S.S.66.021; and

WHEREAS, the Manitowoc Common Council has determined that the City has reasonable need for the property and it is in the best interest of the petitioners, the residents and owners of property in the area to be annexed and the City of Manitowoc to annex the property to the City; and

WHEREAS, the Common Council has reviewed the recommendations of the Wisconsin Department of Development pursuant to Wisconsin Statute S.S. 66.021(12); and

WHEREAS, the petition meets the requirements of Wisconsin Statute S.S.66.021(2)(a)1; or S.S.66.021(2)(a)2;

NOW, THEREFORE, the Mayor and Common Council of the City of Manitowoc do ordain as follows:

SECTION 1. Territory Annexed. Pursuant to Wisconsin Statute S.S.66.021(7), the following described territory in the Town of Newton, Manitowoc County, Wisconsin is hereby annexed to the City of Manitowoc:

DESCRIPTION

A tract of land located in the NW¼ of the NE¼ of Section 1, Township 18 North, Range 23 East, Town of Newton, Manitowoc County, Wisconsin and also known as Tracts B and C of a Certified Survey Map as recorded in Volume 2, Page 177 of CSM at the Manitowoc County Register of Deeds Office and further described as follows; Commencing at the North 1/4 corner of said Section 1, T.18N., R.23E.; thence due East along the section line a distance of 922.7 feet to the point of real beginning; thence continuing due East along the section line a distance of 180 feet; thence South 0° 44' West a distance of 160 feet; thence due West a distance of 180

feet; thence North 0° 44' East a distance of 160 feet to the point of real beginning. Said parcel contains 0.66 acres more or less.

SECTION 2. Aldermanic District and Ward. The territory herein described is made part of the 9th Aldermanic District and 29th Ward of the City of Manitowoc:

SECTION 3. Zone District Classification. The territory annexed is classified as "
"R-4" Single and Two Family Residential District, all according to the attached map.

SECTION 4. Two Thirds Vote. Passage of this Ordinance requires a two thirds vote of the elected members of the Common Council.

SECTION 5. Effective Date. This Ordinance shall take effect on the day after its publication.


