



ORDINANCE ADOPTED BY THE COMMON COUNCIL, CITY OF OCONTO FALLS, AT ITS REGULAR MEETING, JULY 10th, 1990.

The Common Council, City of Oconto Falls, Wisconsin, do ordain as follows:

(1) That the following parcels of land (parcel #1 being entirely owned by Gary Schaal and parcel #2 being owned by the City of Oconto Falls) be hereby annexed to the City of Oconto Falls from the Town of Oconto Falls and that the same be zoned for industrial purposes:

Parcel No. 1: The SE¼ of the NW¼ of Section 24, Township 28 North, Range 19 East, except parts deeded in Vol. 401 of Records, page 501, Vol. 408 of Records, page 722, and Vol. 446 of Records, page 785. Also, except easements to Oconto Electric Cooperative in Vol. 162 Deeds, page 66, and Vol. 402 of Records, page 79, and except right-of-way grant to Michigan Wisconsin Pipeline Company in Vol. 249 of Records, page 135, and except deed to Town of Oconto Falls for town road purposes.

Parcel No. 2: The SW4 of the NW4 of Sec. 24, T.28N., R.19E. and the NW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of said Sec. 24, except that part thereof which is within the following described parcel: Commencing at North 1/4 corner of said Sec. 24; thence due West, along the North line of the NW^1_4 , a distance of 1239.05 feet to the point of beginning; thence due South 417.43 feet; thence due West 626.14 feet; thence due North 417.43 feet; thence due East 626.14 feet to the point of beginning, and reserving the North 33 feet of the said NW4 of the NW4 for highway purposes; also excepting from the NW4 of the NW4 the East 417.43 feet of the South 417.43 feet of the North 834.86 feet; also, reserving to the grantors, their heirs, personal representatives and assigns an easement 15 feet wide extending along the Easterly boundaries of both the SW4 of the NW4 and the NW4 of the NW_{4}^{1} of said Sec. 24, commencing at the intersection with the town road and extending, Northerly, to the parcel 417.43 feet by 417.43 feet heretofore described, for purposes of ingress and egress to such parcel.

The foregoing ordinance was read by Alderman Jensen who moved to suspend the rules and immediately adopt the same.

Seconded by Metzler .
