DIRECT ANNEXATION ORDINANCE

The City Council of the City of Two Rivers does ordain as follows:

SECTION 1. Pursuant to the provisions of Wisc. Stats. Sec. 66.021, the following territory presently lying within the Town of Two Rivers, is hereby annexed to the City of Two Rivers.

A parcel of land in the SW 1/4 of the SW 1/4 of Section 30, T. 20 N., R. 25 E., Town of Two Rivers, described as follows:

Commencing at the SW corner of said Section 30, thence East 253.0 feet along the E-W section line to the point of real beginning, thence continue East 180 feet more or less along said section line, thence N. 0° 28' 15" W. 206 feet more or less, thence S. 89° 18' W. 180 feet more or less, thence S. 0° 28' 15" E. 206 feet more or less to the point of real beginning.

Said parcel contains 0.9 acres more or less.

SECTION 2. The territory described in Section 1 shall be part of the City of Two Rivers for any and all purposes provided by law, and all persons coming to or residing within said territory shall be subject to all ordinances, rules, and regulations governing the City of Two Rivers.

<u>SECTION 3.</u> Pursuant to Section 66.021(7) of the Wisconsin State Statutes, said territory shall be classified for zoning purposes as R-4.

SECTION 4. Upon passage of this ordinance, the City Clerk for the City of Two Rivers is hereby directed to transmit five (5) certified copies of this ordinance, together with five (5) copies of a plat showing the boundaries of the territory attached to the Secretary of State of the State of Wisconsin.
