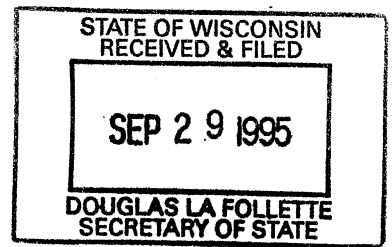

DIRECT ANNEXATION ORDINANCE

The City Council of the City of Two Rivers does ordain as follows:

SECTION 1. Pursuant to the provisions of Wisc. Stats. Sec. 66.021, the following territory presently lying within the Town of Two Rivers, is hereby annexed to the City of Two Rivers.

A tract of land in the SW 1/4 of the NW 1/4 of Section 26, T. 20 N., R. 24 E., Town of Two Rivers, Manitowoc County, Wisconsin and described as follows:

Commencing at the W 1/4 Corner of said Section 26; thence N. 88° 56' 45" E. along the section line 1032.98 feet; thence N. 1° 03' 15" W. a distance of 250.00 feet to the point of real beginning; thence S. 88° 56' 45" W. a distance of 96.70 feet; thence N. 33° 55' 45" W. a distance of 416.00 feet; thence N. 88° 56' 45" E. a distance of 320.79 feet; thence S. 33° 55' 45" E. along the centerline of S.T.H. "147" a distance of 416.00 feet; thence S. 88° 56' 45" W. a distance of 224.09 feet to the point of real beginning.,

Said tract contains 2.57 acres of land to the centerline of S.T.H. "147".

SECTION 2. The territory described in Section 26 shall be part of the City of Two Rivers for any and all purposes provided by law, and all persons coming to or residing within said territory shall be subject to all ordinances, rules, and regulations governing the City of Two Rivers.

SECTION 3. Pursuant to Section 66.021(7) of the Wisconsin State Statutes, said territory shall be classified for zoning purposes as B-2, Business District.

SECTION 4. Upon passage of this ordinance, the City Clerk for the City of Two Rivers is hereby directed to transmit five (5) certified copies of this ordinance, together with five (5) copies of a plat showing the boundaries of the territory attached, to the Secretary of the State of Wisconsin.

SECTION 5. This ordinance shall take effect upon passage and publication hereof.
