Wisconsin.



ORDINANCE NO. 1978-9

AN ORDINANCE APPROVING THE ANNEXATION OF CERTAIN LAND WITH THE TOWN OF

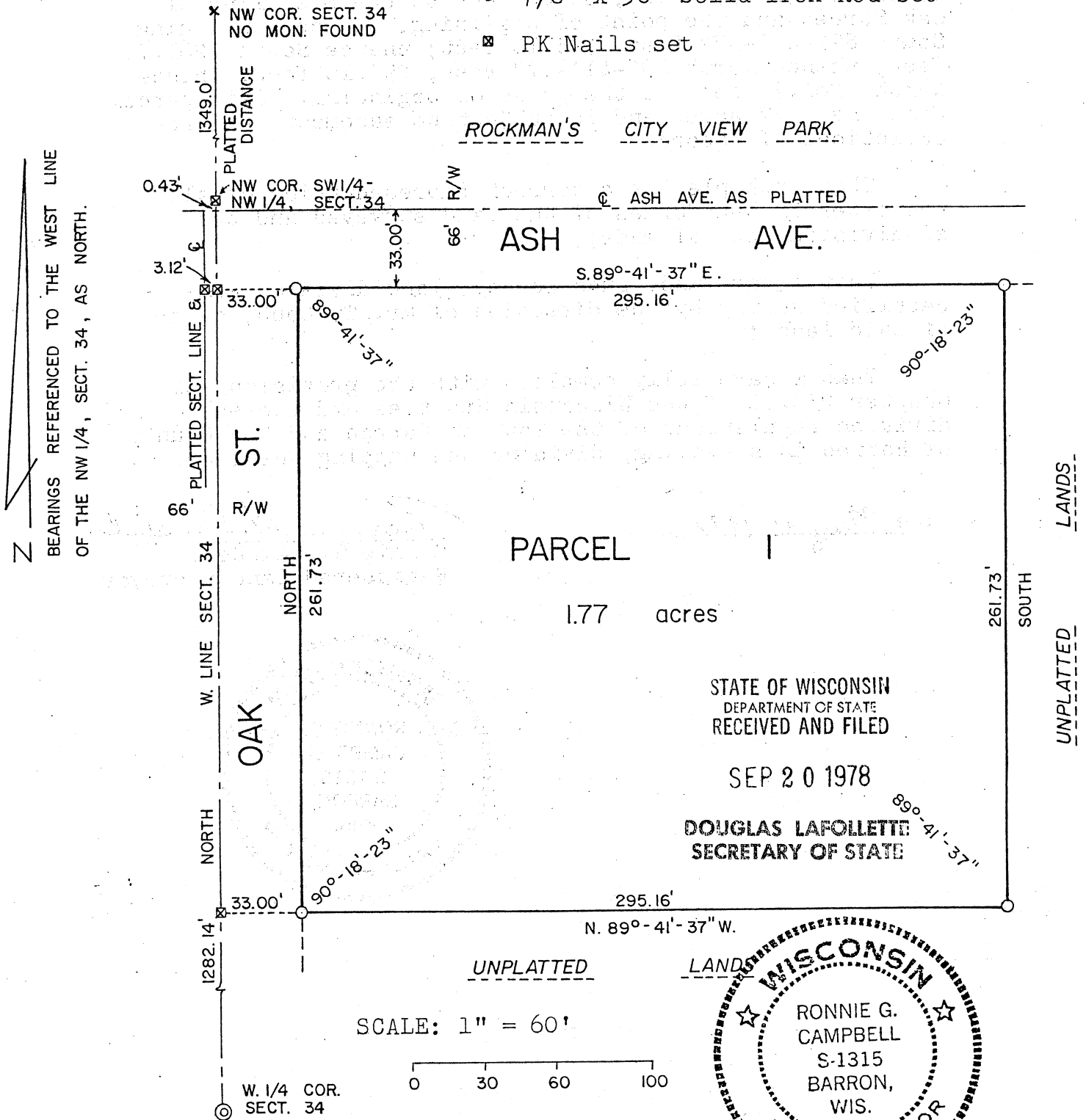
BARRON COUNTY CERTIFIED SURVEY MAP NO. 9-140

SURVEYOR'S CERTIFICATE

I, Ronnie G. Campbell, Registered Land Surveyor, hereby certify that I have surveyed, divided and mapped a parcel of land located in the NW $\frac{1}{4}$, Section 34, T34N, R12W, Town of Barron, Barron County, Wisconsin, which is bounded by a line described as follows:

Commencing at the West $\frac{1}{4}$ corner of Section 34, T34N, R12W, thence North, 1282.14 feet to the South line of Ash Avenue extended as per Rockman's City View Park; thence South 89°-41'-37" East, 33.00 feet to the East line of Oak Street and the point of beginning; thence continuing South 89°-41'-37" East, 295.16 feet; thence South, 261.73 feet; thence North 89°-41'-37" West, 295.16 feet; thence North, 261.73 feet to the point of beginning. Said parcel contains 1.77 acres and is subject to easements and restrictions of record.
