ORDINANCE NO. 285

An Ordinance to Annex a Parcel of Land Lying and Being in the Town Of Medary, La Crosse County, Wisconsin, Being Part of Section 10, Township 16, North, Range 7 West.

The Common Council of the City of Onalaska Do Ordain as Follows:

Section I: Proper petition having been presented to the Common Council of the City of Onalaska praying for the annexation of the following territory to wit:

A parcel of land in Section 10, T16N, R7W, in the SW1/4-NW1/4 and the NW1/4-SW1/4 thereof. Beginning at the SE corner of the SW1/4-NW1/4 Sec. 10, T16N, R7W, thence west along the south line thereof 150 feet; thence N 20° 00' W 120 feet; thence N 63° 30' W 250 feet; thence west, parallel to the south line of said SW1/4 of the NW1/4 a distance of 180 feet; thence N 62° 00' W 285 feet; thence N 32° 00' W 130 feet; thence N 2° 07' W 190 feet more or less to the south line of the Leisso Addition extended west; thence N 32° 00' W to the east right of way line of S.T.H. 157 as laid out and traveled on June 1, 1975; thence S 2° 07' E along said right of way line to a point on the north right of way line of I.H. 90 as of June 1, 1975, thence easterly along said north right of way line of I.H. 90 to the west 1/16 line of said Section 10, thence north along the west 1/16 line of said Section 10 to the point of beginning. Said parcel contains 12.6 acres more or less.

to the City of Onalaska, Wisconsin, from the Town of Medary, La Crosse County, Wisconsin, it is hereby ordained that the above described property be, and the same is hereby annexed to the City of Onalaska, Wisconsin, and it is further ordained that Section 1.02 of the Code of Ordinances of the City of Onalaska entitled "Corporate Limits Description" is hereby amended to include the above described property within the corporate limits of the City of Onalaska, Wisconsin.

Section II: Section 1.01 of the Code of Ordinances of the City of Onalaska entitled "Ward Boundaries" and especially subsection (3) entitled "Third Ward" is hereby amended to include the above described property within the boundaries of the Third Ward, the same is hereby made a part thereof.

Section III: The above described property is hereby zoned A-1, Agricultural District, and all of the provisions of the Code of Ordinances of the City of Onalaska governing A-1, Agricultural Districts, shall apply hereto. Such A-1, Agricultural Zoning, shall continue until the Zoning Ordinance of the City of Onalaska is amended as described in Section 62.23 (7)(d) of the Wisconsin Statutes.

Section IV: This ordinance shall take effect and be in force from and after its passage and publication.
