AN ORDINANCE TO ANNEX A PARCEL OF LAND LOCATED IN PART OF THE SE1/4 OF THE NW1/4 OF SECTION 10, TOWNSHIP 16 NORTH, RANGE 7 WEST, TOWN OF MEDARY, LA CROSSE COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

THE COMMON COUNCIL OF THE CITY OF ONALASKA DOES ORDAIN AS FOLLOWS:

SECTION I. Proper petition for direct annexation by unanimous approval signed by the owners of all of the real property in such territory, there being no electors residing in such territory, having been presented to the Common Council of the City of Onalaska, praying for the annexation of the following described territory, to-wit:

Commencing at the Southwest corner of said Southeastern quarter of the Northwest1/4; thence East along the South line thereof 442 feet; thence North 5 degrees 00 minutes West 650 feet to the point of beginning; thence West 150 feet; thence North 5 degrees West 150 feet; thence East 150 feet; thence South 5 degrees East 150 to the point of beginning.

IT IS HEREBY ORDAINED that the above-described property be and the same is hereby annexed to the City of Onalaska, Wisconsin and it is further ordained that Sec. 1.02 of the Code of Ordinances of the City of Onalaska entitled "Corporate Limits Description" is hereby amended to include the above-described property within the corporate limits of the City of Onalaska, Wisconsin;

SECTION II. Section 1.01 of the Code of Ordinances of the City of Onalaska entitled "Aldermanic Districts-Boundaries - Wards" and especially subsection (3) entitled "Third Aldermanic Ward" is hereby amended to include the above-described property within a boundaries of the Third Aldermanic District, the same is hereby made a part thereof.

SECTION III. The above-described property is hereby

zoned R-1, Residential District, and all of the provisions of the Code of Ordinances of the City of Onalaska governing R-1 Residential District, shall apply thereto. Such R-1 zoning shall be on an interim basis and only for such period of time as is necessary to amend the zoning ordinances of the City of Onalaska as described in Sec. 62.23(7)(d) of the Wis. Stats.
