AN ORDINANCE TO ANNEX A PARCEL OF LAND LOCATED
IN PART OF THE SE1/4 OF THE NW1/4 OF SECTION 10,
TOWNSHIP 16 NORTH, RANGE 7 WEST, TOWN OF MEDARY,
LA CROSSE COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

THE COMMON COUNCIL OF THE CITY OF ONALASKA DOES ORDAIN AS
FOLLOWS:

SECTION I. Proper petition for direct annexation by
unanimous approval signed by the owners of all of the real
property in such territory, there being no electors residing in
such territory, having been presented to the Common Council of
the City of Onalaska, praying for the annexation of the following
described territory, to-wit:

Commencing at the Southwest corner of said
Southeastern quarter of the Northwest 1/4;
thence East along the South line thereof 442
feet; thence North 5 degrees 00 minutes West
650 feet to the point of beginning; thence
West 150 feet; thence North 5 degrees West
150 feet; thence East 150 feet; thence South
5 degrees East 150 to the point of beginning.

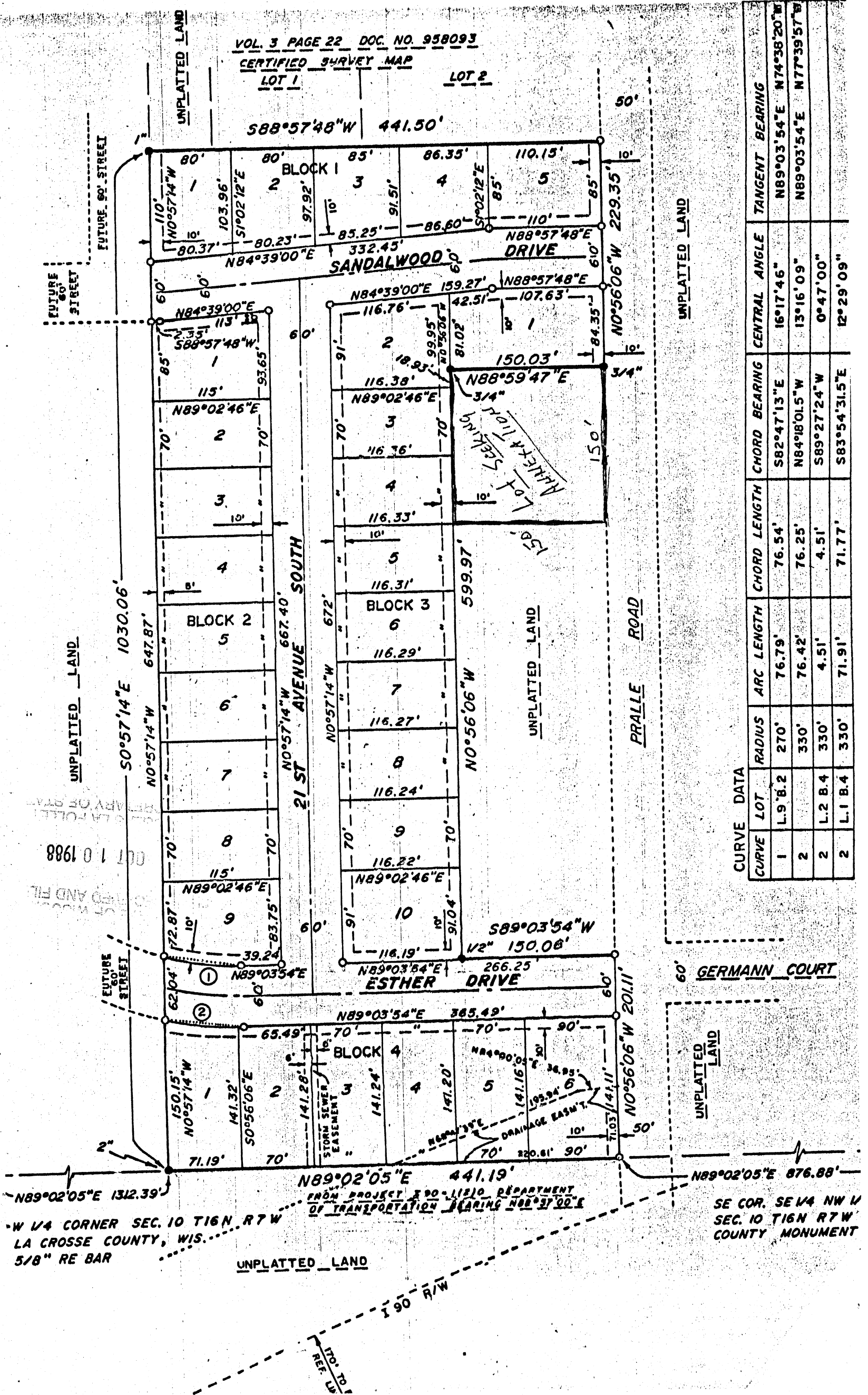
