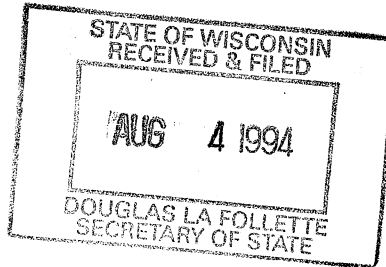

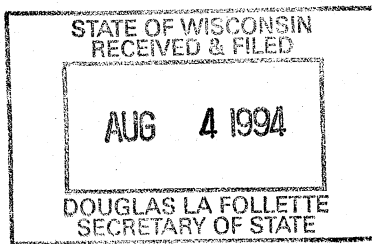

Stats., contesting the validity of an annexation ordinance respecting the "Target" Annexation involving lands more particularly described as follows:

Part of the SE 1/4 SW 1/4 Section 10, T7N, R17E, Town of Summit, Waukesha County, Wisconsin, more particularly described as:

Commencing at the Southeast corner of the Southwest Quarter of said Section 10, Town 7 North, Range 17 East; thence North 75 feet to the place of beginning; thence North 620.21 feet more or less on the Easterly Quarter line of said Section 10, to a point which is 33 feet easterly of the southeasterly corner of the hereinafter described Lot 2, CSM 4925; thence West to the Southeasterly corner of said Lot 2, CSM 4925, thence continue West along the Southerly boundary of said Lot 2, CSM 4925 to the Southwesterly corner of said Lot 2, CSM 4925; thence South parallel to the North and South Quarter line of said Southeast Quarter of Southwest Quarter, Section 10, 620.21 feet more or less; thence south 89° 39' East parallel to the South line of Section 10, 13 rods to the place of beginning.

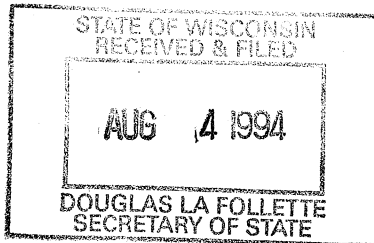


