



CERTIFICATION OF ANNEXATION

I, R. H. Calland, City Clerk of the City of Beloit, County of Rock, State of Wisconsin, DO HEREBY CERTIFY that the following described territory was annexed to the said City of Beloit, pursuant to the Wisconsin Statutes, by an ordinance adopted by the City Council at the regular meeting held on the 18th day of June, 1973:

All that part of the NW 1/4 of section 17, and the NE 1/4 and NW 1/4 of section 18, all in T 1 N, R 13 E, of the 4th P.M. in Turtle Township, Rock County, Wisconsin, which is bounded and described as follows: Commencing at the Northwest corner of said section 17; thence S 89° 21' 30" E along the North line of said section 17, 287.93 feet to a point on the centerline of Creek Road; thence S 10° 32' 10" W along said centerline, 1388.31 feet; thence S 89° 27' 10" W, 36.19 feet; thence S 89° 28' 50" W, 2971.83 feet; thence N 0° 49' 50" W, 1369.11 feet; thence N 89° 10' 10" E, 341.20 feet to the North 1/4 corner of section 18; thence N 89° 32' 10" E along the North line of said section 18, 2652.45 feet to the place of beginning.

I DO FURTHER CERTIFY that there are no persons residing in the described annexation area.
