

URDINANCE NO. 1928

AN ORDINANCE ANNEXING THE CARTER LUMBER, INC. PROPERTY TO THE CITY OF BELOIT

The City Council of the City of Beloit, Rock County, Wisconsin, do ordain as follows:

Section 1. TERRITURY ANNEXED. In accordance with S. 66.021 of the Wisconsin Statutes of 1981–82, and the petition for direct annexation filed with the City Clerk on the 18th day of September, 1984, signed by all of the owners of real property in which no electors reside, in the following described territory in the Town of Beloit, Rock County, Wisconsin, is annexed to the City of Beloit, Wisconsin:

Part of the NE 1/4 of Section 24, T. 1 N., R. 12 E of the 4th P.M., Town of Beloit, Rock County, Wisconsin, to-wit:

Commencing at the southwest corner of block 10 of North View Addition, a recorded subdivision; thence S. 00 15' 10" E 33.0 feet to the east and west centerline of said Section 24 also being the centerline of Cranston Road; thence S. 890 44' 50" W along said east-west centerline 159.86 feet to the easterly line of the Chicago Milwaukee St. Paul and Pacific Railroad; thence N. 100 47' 30" W along said easterly lineTATE OF WISCONSIN of the railroad 84.42 feet to the point of beginning; the PECEIVED AND FILED S. 890 44' 50" W, 271.72 feet; thence N. 00 15' 10" W 191.0 feet thence N. 890 44' 50" E 236.22 feet to the easterly line of the said railroad; thence S. 100 47' 30" DEC 07 1984 E 194.26 feet to the point of beginning. Section 2. EFFECT OF ANNEXATION. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Beloit for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Beloit.

Section 3. TEMPORARY ZONING CLASSIFICATION. (a) Upon recommendation of the Plan Commission the territory annexed to the City of Beloit by this ordinance is temporarily designated to be part of the following districts of the City for zoning purposes and subject to all provisions of Chapter 19 of the Code of General Ordinances of the City of Beloit, entitled "The City of Beloit Zoning Ordinance" relating to such district classifications and to zoning in the City: B-5. (b) The boundaries of these designated districts are established as shown on the map filed in the office of the City Clerk. (c) The Plan Commission is directed to prepare an amendment to the zoning ordinance setting forth permanent classification and regulations for the zoning of the annexed area and to submit its recommendations to the City Council not later than 30 days from the effective date of this ordinance.

Section 4. WARD DESIGNATION. The territory described in Section 1 of this ordinance is hereby made a part of the 22nd Ward of the City of Beloit, subject to the ordinances, rules and regulations of the City governing ward districts.

Section 5. SEVERABILITY. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. EFFECTIVE DATE. The ordinance shall take effect and be in force upon its passage and publication.
