

The following is a description of the corporate limits of the City of Stoughton as of December 20, 1962:

The $S\frac{1}{2}$ of Section 5; part of the $SW\frac{1}{4} NW\frac{1}{4}$, Section 5; part of the $SE\frac{1}{4} NW\frac{1}{4}$, Section 5; part of the $SW\frac{1}{4} NE\frac{1}{4}$, Section 5; part of the $SE\frac{1}{4} NE\frac{1}{4}$, Section 5; part of the $NE\frac{1}{4} SE\frac{1}{4}$, Section 6; part of the $NE\frac{1}{4} NE\frac{1}{4}$, Section 6; the $N\frac{1}{2}$ of Section 8; the $NE\frac{1}{4} SW\frac{1}{4}$, Section 8; the $NW\frac{1}{4} SE\frac{1}{4}$, Section 8; part of the $NE\frac{1}{4} SE\frac{1}{4}$, Section 8; the $W\frac{1}{2} NW\frac{1}{4}$, Section 9; part of the $NE\frac{1}{4} NW\frac{1}{4}$, Section 9; the $W\frac{1}{2} SW\frac{1}{4}$, Section 4; part of the $E\frac{1}{2} SW\frac{1}{4}$, Section 4; part of the $SW\frac{1}{4} NW\frac{1}{4}$, Section 4; part of the $SE\frac{1}{4} NW\frac{1}{4}$, Section 4; all in Town 5 North, Range 11 East, Dane County, Wisconsin, more particularly described as follows:

Beginning at the section corner common to Sections 5, 6, 7 and 8, Town 5 North, Range 11 East;

Thence North 1668 feet along the West line of Section 5 and the centerline of Van Buren Street to the point of intersection with the South line of Wilson Street;

Thence West along the South line of Wilson Street 631.8 feet to the intersection with the East line of Lincoln Avenue;

Thence North 296 feet along the East line of Lincoln Avenue;

Thence East 132 feet;

Thence North 660.2 feet to the South line of Hillcrest Plat;

Thence West 167.1 feet along the South line of said plat to the centerline of Lincoln Avenue;

Thence North 1654.01 feet along the centerline of Lincoln Avenue;

Thence East 669.64 feet to the East line of Section 6;

Thence South 988.39 feet along said East line of Section 6;

Thence East parallel to the East-West quarter line of Section 5, 1336 feet;

Thence South 668.1 feet parallel with the West line of Section 5, the same being the Northerly extension of the East line of Madison Street;

Thence East 1520 feet along the East-West quarter line of said Section 5 to the intersection with the Easterly right-of-way line of the C. M. St. P. & P. R. R.;

Thence Northwesterly along said right-of-way 1138 feet to the intersection with the centerline of North Page Street (also called Williams Drive);

Thence Northeasterly along said centerline 369 feet to the intersection with the North line of the $SW\frac{1}{4} NE\frac{1}{4}$ of Section 5;

Thence East along the North line of the $S\frac{1}{2} NE\frac{1}{4}$ of said Section 1993 feet;

Thence South 1330 feet to the East-West quarter line of said Section 5;

Thence East along the East-West quarter line 823 feet to the East quarter corner of said Section 5;

Thence East along the East-West quarter line of Section 4, 800 feet;

Thence North 660 feet;

Thence East parallel to the East-West quarter line of said Section 4 693 feet;

Thence South parallel to the East line of the $W\frac{1}{2}$ of Section 4,
2640 feet to the centerline of Ridge Street;

Thence West 137.2 feet along the centerline of said street;

Thence South along the East line of the $SW\frac{1}{4}$ $SW\frac{1}{4}$, Section 4,
693 feet to the South line of said Section 4;

Thence South 627 feet along the East line of the $W\frac{1}{2}$ $NW\frac{1}{4}$, Section
9, to the North line of Vernon Street;

Thence East 971.07 feet along the North line of Vernon Street;

Thence South 698.3 feet;

Thence West 970.2 feet to the Southwest corner of the $NE\frac{1}{4}$ $NW\frac{1}{4}$
said Section 9;

Thence South along the East line of the $W\frac{1}{2}$ $NW\frac{1}{4}$, 1361 feet to
the East-West $\frac{1}{4}$ line of said Section 9;

Thence West along said East-West quarter line 1409 feet to the
centerline of the Yahara River;

Thence Southerly and Southwesterly along the centerline of said
Yahara River to a point which is $N82^{\circ}00'E$ from a point on the East
line of the $NW\frac{1}{4}$ $SE\frac{1}{4}$ which point is 973.5 feet from the Northeast
corner of the $NW\frac{1}{4}$ $SE\frac{1}{4}$ said Section 8;

Thence $S82^{\circ}00'W$ to a point on the East line of the $NW\frac{1}{4}$ $SE\frac{1}{4}$,
Section 8, which point is 973.5 feet South of the Northeast corner of
the $NW\frac{1}{4}$ $SE\frac{1}{4}$ said Section 8;

Thence South along said East line 360 feet to the Southeast
corner of the $NW\frac{1}{4}$ $SE\frac{1}{4}$ said Section 8;

Thence West 2680 feet along the South line of the $NW\frac{1}{4}$ $SE\frac{1}{4}$ and
the $NE\frac{1}{4}$ $SW\frac{1}{4}$, said Section 8, to the Southwest corner of the $NE\frac{1}{4}$ $SW\frac{1}{4}$;

Thence North 1335 feet along the West line of the $NE\frac{1}{4}$ $SW\frac{1}{4}$ to
the intersection with the East-West quarter line of said Section 8;

Thence West 1343 feet along said East-West quarter line to the
West quarter corner of Section 8 and the intersection with the
centerline of Van Buren Street;

Thence North along the West line of Section 8 and the centerline
of Van Buren Street 2642.8 feet to the point of beginning.
