CERTIFICATE FOR REPORTING CORPORATE LIMITS OF CITY OR VILLAGE AFTER ALTERATION

Swendsen I. , County of Dane , State of Wisconsin, of Stoughton DO HEREBY CERTIFY that the corporate boundaries of the said City or Village have been altered within the previous 12-month period ending December 1, 1964, and that the following description is the present corporate limits of the said City or Village as of December 1, 1964:

The $S^{\frac{1}{2}}$ of Section 5; part of the $SW^{\frac{1}{4}}$ $NW^{\frac{1}{4}}$, Section 5; part of the NW 1, Section 4; all in Town 5 North, Range 11 East, Dane County, Wisconsin, more particularly described as follows:



It has been called to our attention by Mr. Conrad Lewis that there is an error in the corporate limits description filed in your office for the City of Stoughton in 1964.

The error occurs on the final page of the description, where it reads "Thence West 970.2 feet to the Southwest corner of the NEZ of the NWZ of said Section 9;". It should read as follows:

Thence West 927.7 feet along the South line of the NEt of the NWt; Thence Northerly 134.5 feet parallel with the West line of said NEt of the NWt;

Thence Westerly 23.0 feet parallel with said South line of the NE $\frac{1}{4}$;

Thence Northerly 16.5 feet parallel with said West line;
Thence Westerly 20.4 feet parallel with said South line to the West
line of said NE½ of the NW½ and the East line of the West Half of the NW½;
Thence Southerly along the West line of the NE½ of the NW½ and the
East line of the West Half of the NW½, 1495.5 feet to the East-West
Quarter line of said Section 9;

We are also enclosing a corporate limits map showing this correction. This correction will be included in our new description of December, 1965.
